

for England, with the like consent of the said William, Archbishop of York (testified as aforesaid), in further exercise and execution of the powers or authorities contained in the said Acts of Parliament called "The Church Building Acts," or in some of them, and particularly in the said Act of the first and second years of His late Majesty King William the Fourth, chapter thirty-eight, in the Act of the third and fourth years of Her present Majesty, chapter sixty, in the Act of the seventh and eighth years of Her said Majesty, chapter fifty-six (such two lastly-mentioned Acts being also two of "The Church Building Acts" before named), in the said Act of the fourteenth and fifteenth years of Her said Majesty, chapter ninety-seven, and in the said Act of the nineteenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling them in this behalf, do hereby determine and declare that banns of matrimony shall be published, and that marriages, baptisms, churchings, and burials shall be solemnized or performed at the church of the said particular district of Saint Philip, Kingston-upon-Hull, and do hereby order and direct that all the fees, dues, offerings, or other emoluments to be received in respect of such publication of banns of matrimony, and of such solemnization or performance of marriages, baptisms, churchings, and burials at the same church shall, from and after the next avoidance of the two cures aforesaid, namely, the parish of Sculcoates and the parish of the Holy Trinity, Kingston-upon-Hull, as each such avoidance shall occur, belong to the Incumbent for the time being of the said particular district of Saint Philip, Kingston-upon-Hull: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of the said Ecclesiastical Commissioners for England to concur in or approve the taking of any fee for the performance of the said office of baptism, or for the registration thereof.

In witness whereof, the said Ecclesiastical Commissioners for England, have hereunto affixed their common seal, and the said William, Archbishop of York, has hereunto set his hand and affixed his episcopal seal, this fifth day of February, in the year one thousand eight hundred and eighty-five.

#### SCHEDULE.

The Particular District of Saint Philip, Kingston-upon-Hull, consisting of—

I. All that portion of the parish of Sculcoates, in the town and county of the town of Kingston-upon-Hull, and in the diocese of York, wherein the present Incumbent of such parish now possesses the exclusive cure of souls, which is bounded on the west by an imaginary line commencing upon the boundary which divides the said parish of Sculcoates from the new parish of Saint Paul, Sculcoates, in the town, county, and diocese aforesaid, at the point where Scott-street joins Caroline-street, and extending thence southward for a distance of twenty-five chains or thereabouts along the middle of the last-named street, and along the middle of Worship-street, and of Grimston-street, to the junction of the last-mentioned street with the roadway, called or known as North Side, Queen's Dock, and continuing thence still in the same direction and in a straight line across the the last-named roadway for a distance of one chain

or thereabouts to the boundary on the northern edge of the Queen's Dock, which boundary divides the said parish of Sculcoates from the parish or parochial chapelry of Saint Mary, Kingston-upon-Hull, in the town, county, and diocese aforesaid.

All which said hereinbefore described portion of the parish of Sculcoates aforesaid is bounded upon the remaining sides other than upon the west as aforesaid, that is to say, upon the south, upon the east, and upon the north as follows, upon the south by the parish or parochial chapelry of Saint Mary, Kingston-upon-Hull aforesaid, upon the east partly by the hereinafter described detached portion of the parish of the Holy Trinity, Kingston-upon-Hull, partly by the hereinafter described extra-parochial territory called or known as Charter House, and partly by the new parish of Saint Mark, Hull, all in the town, county, and diocese aforesaid, and on the north by the new parish of Saint Paul, Sculcoates aforesaid.

II. All that detached portion of the said parish of the Holy Trinity, Kingston-upon-Hull, wherein the present Incumbent of such parish still possesses the exclusive cure of souls, which is bounded upon the west by the hereinbefore described portion of the parish of Sculcoates, and by the extra-parochial territory called or known as Charter House aforesaid, upon the north by the hereinbefore described portion of the parish of Sculcoates aforesaid, upon the east by the Old Harbour, or, in other words, by the new parish of Saint Mark, Hull aforesaid, and upon the south by the Queen's Dock aforesaid, or, in other words, by the parish or parochial chapelry of Saint Mary, Kingston-upon-Hull aforesaid.

And III. All that extra-parochial territory, containing by admeasurement one acre two roods and thirty-two perches or thereabouts, which is called or known as Charter House as aforesaid, and which is situate between and consequently is bounded by the above-described portions of the parish of Sculcoates, and of the parish of the Holy Trinity, Kingston-upon-Hull respectively.
