the said liabilities shall be defrayed out of the rate out of which the cost of repair of highways within the borough is for the time being defrayed, under the provisions of the Public Health Act, 1875.

"13. The term 'property' in this Scheme means' and includes all property real and personal, and all things in action, and all rights of common or commonable rights, and rights to toll, and all franchises, privileges, and rights which have any pecuniary value, and all charters, records, deeds, books, and documents, all rights and all claims to relief, and all rights and claims to avoid contracts or otherwise, and includes any estate or interest, legal or equitable, in or in respect of any property so defined.

"14. The term market property in this Scheme means and includes rights to market tolls, and all franchises, privileges, and rights relating to markets, and all lands und premises used for or in connection with the purposes of markets.

The following is a copy of the translation of the decision :--

"Agricultural machinery and implements imported from abroad, without steam motors, and specially designated, as well as models of the same, are subjected to a duty of fifty copecks in gold per poud.

"Supplementary parts of agricultural machines and instruments shall be admitted under those Articles of the Tariff which apply to them."
