To the Churchwardens and Overseers of the Poor of the parish of Ore, in the county of Sussex;—

And to all others whom it may concern.

W HEREAS the population of the said parish of Ore, according to the last census, exceeds two thousand persons;

And whereas at a Meeting of the Vestry of the said parish, held after due notice in that behalf, on Thursday, the 19th day of March, 1885, it was resolved,—

"That the Churchwardens and Overseers of "the parish be authorized to apply to the "Local Government Board to make an "Order to put in force in the said parish so "much of the Statute 13 and 14 Vict., cap. "57, as relates to the appointment of a "Vestry Clerk, and that the duties to be "performed by him shall be the whole of the "duties of a Vestry Clerk as defined by the "Act, and that the salary to be assigned to "him shall be twelve pounds a year."

And whereas the Churchwardens and Overseers of the said parish have made application in writing to the Local Government Board, pursuant to the above Resolution:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby order as follows:

ARTICLE I.—So much of the Act passed in the fourteenth year of the reign of Her Majesty, intituled "An Act to prevent the holding of "Vestry or other Meetings in Churches, and for "regulating the appointment of Vestry Clerks," as relates to the appointment of a Vestry Clerk, shall forthwith be applied to and be put in force in the said parish of Ore.

ARTICLE II.—The Churchwardens and Overseers of the Poor of the said parish shall pay to the person for the time being appointed to the office of Vestry Clerk, under the provisions of the above-mentioned Act and of this Order, a salary at the rate of twelve pounds per annum, or such other remuneration for the performance of the duties of that office as We may from time to time direct or approve.
