1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with swine-fever.

(PLEURO-PNEUMONIA.)

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Declaration described in the Schedule to this Order, made by the Committee for the Faversham Division of the Local Authority for the county of Kent, declaring the existence of pleuro-pneumonia at the Place therein mentioned, is hereby cancelled, and the Infected Place thereby declared shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the ninth day of May, one thousand eight hundred and eighty-five.

THE CONTAGIOUS DISEASES (ANIMALS) TRANSFER OF PARTS OF DISTRICTS ACT, 1884.

THE Lords and others of Her Majesty's Most Honourable Privy Council approved on the 5th day of May, 1885, of an Agreement bearing date the 6th day of April, 1885, made between the Justices of the Peace of the county of Hereford in General Quarter Sessions assembled of the one part, and the Justices of the Peace of the county of Monmouth in General Quarter Sessions assembled of the other part, whereby the jurisdiction, for the purposes of The Contagious Diseases (Animals) Act, 1878, of the parish, hamlet, or township of Fwddog, in the county of Hereford, was, from and after the date of such approval by the Privy Council as aforesaid, transferred to the district of the county of Monmouth Agricultural Department, Privy Council Office, 5th May, 1885.
