WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Yetminster, with the chapelry of Chetnole annexed thereto, in the county of Dorset, and in the diocese of Salisbury, and to his successors, Incumbents of the same vicarage, all that cottage or tenement with the orchard adjoining and the appurtenances thereto belonging, being next to the parsonage or house of residence of the said vicarage of Yetminster, and being part of the premises numbered 309 on the tithe apportionment map of the parish of Yetminster, formerly in the occupation of Robert White England, late in the occupation of the Reverend George Southwell, Clerk in Holy Orders, but now in the occupation of the Reverend Robert Scott McDowell, Clerk in Holy Orders, to have and to hold the same premises to the use of the said Incumbent of the said vicarage of Yetminster, and of his successors, Incumbents of the same vicarage for ever.
