The limits of the following Area which is declared by Order of Council dated the twentysecond day of April, one thousand eight hundred and eighty-five, to be an Area infected with swine-fever (namely),—in the borough of Birmingham, in the county of Warwick, comprised within the following boundaries, that is to say, Lodge-road and Foundry-road on the north, the borough boundary on the west, Dudley-road and the London and North-Western railway on the south, and Monument-road and Icknield-street on the east,—are hereby extended so as to include the Area described in the Schedule to this Order, and the Area described in the Schedule to this Order is hereby declared to be an Area infected with swine-fever.

2. This Order shall take effect from and immediately after the nineteenth day of May, one thousand eight hundred and eighty-five.
