## DUDLEY AUGUST FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Sir Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. By Memorial, dated 30th June, 1885, a representation has been duly made to me by the Council of the borough of Dudley, as owners, that a Fair has been annually held on the first Monday in August, in the said borough, and that it would be for the convenience and advantage of the public that the day for the holding of such Fair should be altered, and that, instead of being held as aforesaid, such Fair should in future be held on the second Monday in August in each year.

2. On the 30th day of July, 1885, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the said proposed alteration in the time for holding the said Fair. *Richard Assheton Cross.*
