enter into the receipt of the endowments charged therewith or any part thereof and to receive and take the same until he shall thereby or otherwise be paid and satisfied the same rent-charge and the arrears thereof due at the time of such entry or afterwards to become due during his being in possession of the same premises together with all costs and expenses occasioned by the non-payment thereof and for the purpose of collecting receiving and recovering such endowments or any of them to use exercise and enjoy all such powers and remedies for collecting recovering and enforcing payment thereof and of the annual sums payable for or towards the raising or making up the same as may be statutably exercised or exorcisable by him under the law then in force. Provided always that if at any time the incumbent for the time being of the said benefice of Houghton-le-Spring shall by any deed duly executed by him under his hand and seal in accordance with the provisions of any statute in that behalf enabling him grant convey and annex to the said benefice of Herrington any part or parts of the rectorial endowments belonging to the said benefice of Houghton-le-Spring which shall in the opinion of the Bishop of Durham for the time being be a good and fair equivalent for the said yearly charge of one hundred pounds hereby proposed to be created as aforesaid then the same annual sum or yearly charge of one hundred pounds shall thereupon and thenceforth cease and determine and be no longer payable as hereinbefore recommended and proposed.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocess of Durham. ## PRESENT.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty, chapter ninety-four of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four, of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four, and of the Act of the forty-seventh and forty-eighth years of Her Majesty chapter sixty-five duly propared and laid before Her Majesty in Council a scheme or representation, bearing date the fourth day of Junc, in the year one thousand eight hundred and eightyfive, in the words and figures following, that is to say :--

England, acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four, of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four of the Act of the thirtysecond and thirty-third years of Your Majesty chapter ninety-four and of the Act of the fortyseventh and forty-eighth years of Your Majesty chapter sixty-five have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the district of Saint John the Baptist Great Marlborough-street in the county of Middlesex and in the diocese of London.

"Whereas by the authority of an Order of Your Majesty in Council bearing date the seventh day of August in the year one thousand eight hundred and sixty-five and published in the London Gazette upon the eighth day of the same month ratifying a scheme of the Ecclesiastical Commissioners for England prepared under the provisions of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen, and of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven (the New Parishes Act 1843) certain portions of the parish of Saint James Westminster and of the new parish of Saint Luke Westminster both in the county of Middlesex and diocese of London aforesaid were constituted a separate district for ecclesiastical purposes, and the same was called 'The District of Saint John the Bapust Great Marlborough-street.'

"And whereas no church has yet been provided for or consecrated within the said district of Saint John the Baptist Great Marlborough-street.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said district should be altered by way of extension so that they shall include the portion hereinafter described of the district chapelry of Saint Thomas Regent-street sometime part of the said parish of Saint James, Westminster.

"Now therefore with the consent of the Right Honourable and Right Reverend Frederick Bishop of the said diocese of London (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation the boundaries of the said district of Saint John the Baptist Great Marlborough-street shall be altered by way of extension so that they shall include all that portion of the said district chapelry of Saint Thomas Regent-street which is described in the schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended, and that from and after the said day of publication as aforesaid and without any assurance in law other than such duly gazetted Order the said portion of the district chapelry of Saint Thomas Regentstreet so to be included within the boundaries of the district of Saint John the Baptist Great Marlborough-street as aforesaid shall become and be and form part of the same district.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.
