"The SCHEDULE to which the foregoing Scheme has reference.

"The District of the Holy Trinity Latimer-

road, Notting Hill, being :-

"All that part of the new parish (sometime consolidated chapelry) of Saint Clement, Kensington, in the county of Middlesex and in the diocese of London, wherein the present incumbent of such new parish now possesses the exclusive cure of souls, which is bounded on the north by an imaginary line commencing at the point in the centre of the bridge which carries the line of the Hammersmith and City Branch of the Metropolitan Railway over Walmer-road where the boundary which divides the new parish of Saint Mark, Notting Hill, in the county and diocese aforesaid from the said new parish of Saint Clement, Kensington, joins the boundary dividing the lastnamed cure from the district chapelry of Saint Clement Notting Hill in the county and diocese aforesaid, and extending thence first north-westward then westward and then south-westward along the middle of the said Walmer-road for a distance of twenty-four and a half chains or thereabouts to its junction with Latimer-road and continuing thence still south-westward across the last-named road to the north-eastern end of the wall or fence which divides the house and premises known as No. 289 Latimer-road from the house and premises known as 287 Latimer-road, and continuing thence still south-westward along the said wall or fence to its south-western end on the north-eastern side of the line of the West London Junction Railway, and continuing thence still in the same direction and in a straight line to the boundary in the middle of the last-named line of railway which boundary divides the said new parish of Saint Clement Kensington from the district parish of Saint Stephen Hammersmith in the county and diocese aforesaid.

"All which said hereinbefore described part of the new parish of Saint Clement Kensington aforesaid is bounded upon the remaining sides other than upon the north as aforesaid, that is to say upon the west and upon the south-east as follows, upon the west by the said district parish of Saint Stephen Hammersmith, or in other words by the line of the West London Junction Railway aforesaid, and upon the south-east by the said district chapelry of Saint Clement, Notting Hill, or in other words by the line of the Hammersmith and City Branch of the Metropolitan Railway

aforesaid."

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the patron and to the incumbent of the vicarage of the said new parish of Saint Clement, Kensington, out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patron and incumbent have respectively signified their assent to such scheme:

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixteenth and seventeenth years of Her Majesty, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her Majesty chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the sixteenth day of July, in the year one thousand eight hundred and eighty-five, in the words and figures following,

that is to say :-

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the sixteenth and seventeenth years of Your Majesty chapter fifty and of the Act of the twenty-third and twenty-fourth years of Your Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to each of three benefices within the borough of Nottingham and the town and county of the town of Nottingham respectively and within the diocese of Southwell namely the benefice (being a vicarage) of Old Radford, and the benefice (being a vicarage) of Basford with Cinderhill both in the borough of Nottingham and the benefice (being a rectory) of Saint Peter within the town and county of the town of Nottingham, by way of exchange for the ownership of the advowson or perpetual right of patronage of and presentation to six other benefices within the county of Nottingham and diocese of Southwell namely the benefice (being a vicarage) of Balderton the benefice (being a vicarage) of Clifton North the benefice (being a rectory) of Clayworth, the benefice (being a vicarage) of Farndon, the benefice (being a vicarage) of Skegby, and the benefice (being a vicarage) of South Scarle with Girton and Besthorpe.

"Whereas the advowson or perpetual right of patronage of and presentation to each of the said three benefices of Old Radford and Basford with Cinderhill and Saint Peter Nottingham is vested in Your Majesty, Your heirs and successors and is exercised on behalf of Your Majesty by the Lord High Chancellor of Great Britain for the time

being.

"And whereas the advowson or perpetual right of patronage of and presentation to each of the said six benefices of Balderton and Clifton North and Clayworth and Farndon and Skegby and South Scarle with Girton and Besthorpe is vested in the Bishop of the said diocese of Southwell and his successors.

"And whereas the Right Honourable Hardinge Stanley, Baron Halsbury, now Lord High Chancellor of Great Britian and the Right Reverend George now Bishop of the said diocese of Southwell, have respectively signified to us their desire that the patronage of the said nine benefices and of the churches thereof respectively may be assigned and transferred by way of exchange in manner hereinafter recommended and proposed.

"And whereas we have made due enquiry and calculation as to the circumstances and relative values of the said benefices and patronage and we do hereby certify to Your Majesty that the circumstances and present values of the said benefices respectively are as set forth in the schedule hereunto annexed.

"Now therefore with the consent of the said
