(SWINE-FEVER.)

**A**T the Council Chamber, Whitehall, the 2nd day of December, 1885.

By Her Majesty's Most Honourable Privy Council.

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The limits of the following Area which is declared by Order of Council dated the twelfth day of August, one thousand eight hundred and eighty-five, to be an Area infected with swine-fever (namely),—in the county of Glamorgan, comprising the whole of the parish of Ystradyfodwg (excepting Rhigos), so much of the parish of Llanwonno as lies within half a mile of the Rhondda Fach River and so much of the parishes of Llantrisant and Llanwonno as lies within a mile of the Rhondda Fawr river above Hafod Railway Bridge,—are hereby extended so as to include the Area described in the First Schedule to this Order, and the Area described in the First Schedule to this Order is hereby declared to be an Area infected with swine-fever.

2. Each of the Areas described in the Second Schedule to this Order is hereby declared to be an Area infected with swine-fever.

3. This Order shall take effect from and immediately after the fourth day of December, one thousand eight hundred and eighty-five.
