The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the fifth day of November, in the year one thousand eight hundred and eighty-five, in the words following, that is to say:—

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken out of the parish of Aston-juxta-Birmingham in the county of Warwick and in the diocese of Worcester.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said parish of Aston-juxta-Birmingham which is hereinafter mentioned and described should be constituted a separate district in manner hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine worship.

"And whereas certain well-disposed persons have contributed and paid to the credit of our account at the Bank of, England a sum of three thousand pounds sterling in aid of the endowment of the district hereinafter recommended to be constituted and so soon as the said district shall have become a new parish under the provisions of the secondly hereinbefore-mentioned Act then of the said new parish and of the maintenance of the minister or incumbent thereof for the time being and we have in respect of such sum agreed and have undertaken to provide and pay by equal half-yearly payments on the first day of May and the first day of November in each and every year

to such minister or incumbent as aforesaid when duly licensed in accordance with the provisions of the lastly mentioned Act the sum of one hundred pounds per annum so long as the said capital sum shall remain in our bands.

" And whereas the said capital sum of three thousand pounds sterling has been so contributed and paid as aforesaid upon the understanding and condition that we should also make and pay out of the common fund created by the firstly herein named Act to the minister or incumbent for the time being of the said district or new parish when duly licensed as before mentioned a grant of fifty pounds per annum and upon the further understanding and condition that (such arrangement appearing to us to be expedient) we should recommend and propose to Your Majesty in Council that the whole right of patronage of the said district or new parish and of the nomination of the minister or incumbent thereof should be assigned to the Bishop for the time being of the said diocese of Worcester.

"And whereas we have undertaken and agreed to make the said grant of fifty pounds per annum as aforesaid by an instrument to be executed by us under our common seal in accordance with the provisions of the Act of the twenty-ninth and thirtieth years of Your Majesty chapter one hundred and cleven.

"Now therefore with the consent of the Right Reverend Henry Bishop of the said diocese of . Worcester (in testimony whereof he the said Bishop has signed and sealed this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that all that part of the said parish of Aston-juxta-Birmingham which is described in the schedule hereunder written all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint Basil, Deritend.'"

And we further recommend and propose that the whole right of patronage of the said district so recommended to be constituted and when such district shall have become a new parish as aforesaid then of the said new parish and of the nomination of the minister or incumbent thereof shall without any assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absoluted vested in and shall and may from time to time be exercised by the said Henry, Bishop of the said diocese of Worcester, and by his successors, Bishops of the same diocese for ever.

" And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Basil Deritend, be-

"All that part of the parish of Aston-juxta-Birmingham (being a portion of the hamlet of Deritend) in the county of Warwick and in the diocese of Worcester wherein the present Incumbent of such parish still possesses the exclusive cure of souls, which is bounded on the south-west by an imaginary line commencing upon the boundary which divides the said hamlet of Deritend and the parish of Aston-juxta-Birmingham aforesaid from the consolidated chapelry of Saint Gabriel Birmingham in the county and diocese aforesaid at a point in the middle of the River Rea on the north-eastern side of Deritend Bridge and extending thence south-westward and in a direct line to the centre of the said bridge and extending thence south-eastward to and along the middle of High-street Deritend for a distance of fourteen chains or thereabouts to the boundary which divides the said parish of Aston-juxta-Birmingham from the new parish of the Holy Trinity Bordesley in the county and diocese aforesaid which boundary also divides the said hamlet of Deritend from the hamlet of Bordesley.

"All which said hereinbefore-described part of the parish of Aston-juxta-Birmingham aforesaid is bounded upon the remaining sides other than upon the south-west as aforesaid that is to say upon the south-east upon the east and upon the north-west as follows upon the south-east by the new parish of the Holy Trinity Bordesley aforesaid upon the east by the new parish of Saint Andrew Bordesley in the county and diocese aforesaid and upon the north-west partly by the new parish of Ashted in the said county and diocese and partly by the consolidated chapelry of Saint Gabriel Birmingham aforesaid."

And whereas drafts of the said scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the patrons and to the incumbent of the parish of Aston-juxta-Birmingham out of which parish it is intended that the district recommended in such scheme to be constituted shall be taken.

And whereas the incumbent of the said parish of Aston-juxta-Birmingham has made certain observations upon the said scheme.

And whereas the patrons of the same parish have offered certain objections to the said scheme.

And whereas the said scheme has notwithstanding such observations and objections as last mentioned, been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been

duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester.

W HEREAS the Ecclesiastical Commissioners VV for England have, in pursuance of the Act of the sixteenth and seventeenth years of Her Majesty, chapter fifty, and of the Act of the twenty-third and twenty-fourth years of Her Majesty chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the nineteenth day of November, in the year one thousand eight hundred and eighty-five, in the words and figures following, that is to say :-

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the sixteenth and seventeenth years of Your Majesty chapter fifty and of the Act of the twenty-third and twenty-fourth years of Your Majesty chapter one hundred and twenty-four have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting an exchange of the patronage of the benefice (being a vicarage) of Totnes in the county of Devon, and in the diocese of Exeter, the patronage of which said benefice and vicarage belongs to the Crown, and is exercised on behalf of Your Majesty by the Lord High Chancellor of Great Britain for the time being, in virtue of his office: for the patronage of the benefice (being a rectory) of Bradstone, in the said county of Devon and in the said diocese of Exeter; the patronage of which said lastly named benefice belongs to the Bishop for the time being of the diocese of Exeter

in right of his See. "Whereas the Right Honourable Hardinge Stanley, Baron Halsbury, now Lord High Chancellor of Great Britian and the Right Reverend Edward Henry now Bishop of the said diocese of Exeter, have respectively signified to us their desire that the patronage of the said two benefices of Totnes and Bradstone may be rearranged by way of exchange in manner hereinafter recom-

mended and proposed.

"And whereas we have made due enquiry and calculation as to the circumstances and relative values of the said two benefices and of the patronage thereof respectively, and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two benefices are as set forth in the schedule hereunto annexed.

"Now therefore with the consent of the said Hardinge Stanley, Baron Halsbury, Lord High Chancellor of Great Britain acting as such Lord High Chancellor on behalf of Your Majesty (in testimony whereof he has to this scheme set his hand and seal) and with the consent of the said Edward Henry, Bishop of the said diocese of Exeter, acting as such Bishop (in testimony whereof he has to this scheme set his hand and his episcopal seal) we the Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said benefice of Totnes and the church thereof shall be assigned and transferred from Your Majesty your heirs and successors and shall become and be absolutely vested in and shall and may from time to time and at all times be exercised by the said Edward Henry Bishop of the said diocese of Exeter and his successors Bishops of the same diocese for ever: and that in exchange for the same, the whole advowson or perpetual right of patronage of and presentation to the said benefice of Bradstone and the church thereof shall in like manner and upon and from the same date be assigned and transferred from the said Edward Henry Bishop of the said diocese of Exeter and from his succes-

sors Bishops of the same diocese and shall become and be absolutely vested in Your Majesty Your heirs and successors, and shall and may from time to time and at all times be exercised by the said Hardinge Stanley, Baron Halsbury, or other the Lord High Chancellor of Great Britain, for the time being acting on behalf of Your Majesty in right of the Crown.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.

The QUEEN's Most Excellent Majesty in Council. WHEREAS by an Act passed in the session of Parliament held in the sixteenth and seventeenth years of Her Majesty's reign, intituled " An Act to amend the laws concerning the burial of the dead in England beyond the limits of the "Metropolis, and to amend the Act concerning the burial of the dead in the Metropolis," it is enacted that, in case it appears to Her Majesty in Council, upon the representation of one of Her Majesty's Principal Secretaries of State, that for the protection of the public health the opening of any new burial-ground in any city or town, or within any other limits, save with the previous approval of one of such Secretaries of State, should be prohibited, or that burials in any city or town, or within any other limits, or in any burial-grounds or places of burial; should be wholly discontinued or should be discontinued subject to any exception or qualification, it shall be lawful

for Her Majesty, by and with the advice of Her Privy Council, to order that no new burial-ground shall be opened in any city or town, or within such limits, without such previous approval; or (as the case may require) that, after a time mentioned in the Order, burials in such city or town, or within such limits, or in such burial-grounds or places of burial, shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and so from time to time as circumstances may require; provided always, that notice of such representation, and of the time when it shall please Her Majesty to order that the same be taken into consideration by the Privy Council, shall be published in the London Gazette, and shall be affixed on the doors of the churches or chapels of, or on some other conspicuous places within the parishes affected by such representation, one month before such representation is so considered:

And whereas by another Act passed in the session of Parliament held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the laws concerning "the burial of the dead in England," it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit:

And whereas the Right Honourable Sir Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, has made a representation stating that he is of opinion that the Order of Her Majesty in Council of the fourth day of April, one thousand eight hundred and fiftysix, in so far as it affects burials in the churchyard of Saint Michael, Saint Albans, in the county of Hertford, should be varied, and that the following directions should be substituted for those contained in the said Order with respect to burials in the church and churchyard of Saint Michael, viz. :-

That burials be discontinued entirely in the Parish Church of Saint Michael, Saint Albans, in the county of Hertford, and in the churchyard within five feet of the Infant School; and also in the rest of the church-

yard, except as follows:-

(a.) In such walled graves as are now existing in the churchyard burials may be allowed on condition that every coffin buried therein be separately enclosed by stonework

or brickwork properly cemented.

(b.) In such earthen graves now existing in the churchyard as can be opened to the depth of five feet without exposing coffins or disturbing human remains burials may be allowed of so many of the relations of those interred therein at the date of the Order as can be buried at or below that depth.

(c.) In such reserved grave spaces in the churchyard (as have never before been buried in, and, when opened, are free from water) burials may be allowed of so many members of the families to whom they may be allotted as can be buried at or below the

depth of five feet.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council on the

tenth day of February next:

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette; and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation one month before the said tenth day of February next.

UNIVERSITY OF CAMBRIDGE.

WE, the Chancellor, Masters, and Scholars of the University of Cambridge, having on the tenth day of December, one thousand eight hundred and eighty-five, made under the provisions of the Universities of Oxford and Cambridge Act, 1877, the following Statute

STATUTE A. CHAPTER II. SECTION 19. Affiliated Colleges.

THE University shall have power to adopt as an affiliated College in any place within the United Kingdom, or in any part of the British dominion, any institution founded for the educa- I make the following appointments to the First

tion of adult students, with such conditions as the provision of lectures, and as to the rules and arrangements for the students, as may be determined from time to time by Grace.

Students of the institution who shall have continued members of it for such length of time, not less than two years, and shall have attended such lectures, and passed such examinations, as may be required from time to time by Grace of the Senate shall, if admitted as members of the University, be deemed to have kept already three of the terms required for any degree.

The University shall have power also to terminate at any time by Grace the connexion of the University with the institution as an affiliated

College.

The University shall have power also to admit on like conditions to the privileges of students of an affiliated College adult students attending a course of education conducted by a Committee in concert with the University in places where there is no affiliated College.

(No. 286.)—Australia—North-East Coast. Albany Pass Approach.

Non-existence of England Shoal, Extension of Harrington Shoal.

THE following information has been received from Commander Hoskyn, H.M. Surveyingvessel, "Myrmidon," relative to an unsuccessful search for England Shoal, and to the extension of Harrington Shoal, approach to Albany Pass from the south-eastward:—

The reported position of England Shoal was crossed by the "Myrmidon" several times, the lead giving 10 to 12 fathoms, and no indications of shallow water were seen from the deck or aloft, although shoals in the neighbourhood were distinctly visible.

Harrington Shoal was found to extend in a

north-westerly direction, for a distance of nearly 2 miles from the black beacon on Z reef; the depths near the edge being estimated as  $1\frac{1}{2}$  to 2 fathoms at low water. From this position, North Brother (37 feet high) shows against Mt. Adolphus Island and is not easily discerned, but Morilug Island (102 feet high), somewhat resembling it in appearance, is clearly seen.

From the foregoing, it is considered that the ship "England," in April, 1874, struck on this extension of Harrington Shoal; on which there is also little doubt that the S.S. "Bonnington" grounded in August, 1884.—England Shoal has therefore been expunged from the Admiralty

Charts.

Note.—The "course recommended" on the charts to Albany Pass from the southward, should be altered 4 cables to the westward, near Harrington Shoal, so as to lead about midway between the extension of that shoal as reported above and the 4-fathoms patches.

Bye-Laws as to Tramways. OTICE is hereby given, that the following Bye-laws and Regulations have been made by the Local Board for the district of South

Hornsey, as the Local Authority, under section 46 of the Tramways Act, 1870.

1. For the purpose of these Bye-laws and Regulations, the term "car" shall mean any engine or carriage using any tramway laid down within the said district, and the terms "driver" and "conductor" shall respectively mean the driver and conductor or other person having charge of an engine or car.

2. The driver of every car shall cause the same to be driven at a speed of not less than four miles an hour on the average, and not exceeding eight

miles an hour.

3. The driver of every car shall so drive the same that it shall not follow a preceding car at a

less distance than fifty yards.
4. Subject to the requirements of Bye-laws Nos. 3 and 5, the driver or conductor of a car shall stop the same for the purpose of setting down or taking up passengers when required by any passenger desiring to leave the car or by any person desirous of travelling by the car for whom there is room and to whose admission no valid objection can be made. Provided that nothing in this Bye-law shall require a car to be stopped on any gradient steeper than 1 in 25.

5. Except at a passing place or terminus, no car shall be stopped at the intersection or junction of two or more streets or roads, nor within ten yards of a car on an adjoining line of rails.

6. The driver of a car on coming in sight of a vehicle standing or travelling on any part of the road so as not to leave sufficient space for the car to pass, shall sound his bell or whistle as a warning to the person in charge of such vehicle, and that person shall with reasonable despatch cause such vehicle to be removed so as not to obstruct the car.

7. No person shall in any way wilfully impede or interfere with the traffic on the tramways, nor shall any driver or conductor needlessly cause interruption to the ordinary road traffic.

8. Every driver, conductor, or other person offending against any of these Bye-laws and Regulations shall be liable to a penalty not exceeding forty shillings for each offence, and not exceeding for any continuing offence ten shillings for every day during which the offence continues.
