

'the Friends Cemetery,' and continuing thence still north-eastward along the last-described wall or fence for a distance of four chains or thereabouts to its north-eastern end on the south-western side of Snithdown-road and continuing thence still north-eastward and in a direct line to the boundary in the middle of the last-named road, which boundary divides the said particular district of Saint Clement Toxteth Park from the herein-after described portion of the district chapelry of Christ Church Toxteth Park aforesaid.

"II. And also all that contiguous portion of the said district chapelry of Christ Church Toxteth Park which is detached (or nearly detached) from the main body of the same district chapelry and which is bounded upon the south-west by the particular district of Saint Clement Toxteth Park aforesaid and is touched at its north-western extremity by a portion of the parish of Walton-on-the-Hill in the county and diocese aforesaid and is bounded upon the north-east and upon the east by the new parish of the Holy Trinity Wavertree in the said county and diocese and upon the south by the particular district of Saint Matthew and Saint James Mossley Hill in the same county and diocese."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool.

THE following Statute, passed on the 12th day of January, 1886, by the Governing Body of Oriel College, Oxford, and sealed on the 18th day of January, 1886, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in the Universities of Oxford and Cambridge Act, 1877:—

A Statute to amend a Statute, made by the University of Oxford Commissioners under the Universities of Oxford and Cambridge Act, 1877 (40 and 41 Vict., c. 48), and approved by the Queen in Council on the 3rd day of May, 1882, in relation to Oriel College, in the University of Oxford, duly made at a General Meeting of the Provost and Fellows of the said College, specially summoned for this purpose, held on the 12th day of January, 1886, and passed at such meeting by the votes of two-thirds of the number of persons present and voting, and submitted to Her Majesty the Queen in Council.

Whereas by Statute IV, 7, made by the University of Oxford Commissioners under the Universities of Oxford and Cambridge Act, 1877, and approved by the Queen in Council on the 3rd day of May, 1882, in relation to Oriel College, in the University of Oxford, it was enacted as follows:—

"7. Four exhibitions shall always be maintained within the College, to be called the exhibitions of Adam de Brome, and to be filled up by the election of deserving persons whom the Provost and Fellows shall have ascertained to be in need of

support at the University. Each Exhibitioner shall receive such sum, not exceeding £80 per annum, from the Exhibition Fund, as the Provost and Fellows shall from time to time determine."

"The Exhibitors shall be elected by the Provost and Fellows, with or without examination, and with or without public notice, as the electors shall think fit."

"The conditions of tenure of these Exhibitions shall be the same in all respects as those of Scholarships, save that in the event of any one of the Exhibitors being elected to a Scholarship within the College, or ceasing, in the judgment of the Provost and Fellows, to be in need of support at the University, he shall thereupon vacate his Exhibition."

And whereas under the said Statutes the emoluments of Adam de Brome Exhibitors are the same as those of Scholars of the College, and the conditions of tenure, other than that of the Exhibitors being in need of support at the University, of Adam de Brome Exhibitions are the same in all respects as those of Scholarships within the College.

And whereas it appears to us the Provost and Fellows of the said College, that the abilities and attainments of the persons qualified for election to Exhibitions of Adam de Brome, and offering themselves as candidates for such Exhibitions at elections held with examination and with public notice, are in many cases equal or not inferior to those of candidates for Scholarships within the College, and that it is desirable that such persons, if elected to such Exhibitions, should not be placed in respect of rank or title in a position inferior to that which they would hold if elected to Scholarships within the College.

We, the said Provost and Fellows of the said College, being the governing body thereof, do hereby in exercise of the power given to us by the 54th section of the said Act, alter Statute IV, 7, as hereinbefore set out, by adding thereto the following words:—

"It shall be lawful for the Provost and Fellows, at or upon the election after examination, and with public notice of any such Exhibitioner, or under and in pursuance of regulations made by them from time to time respecting the election after examination and with public notice of such Exhibitors to assign to any Exhibitioner or Exhibitors so elected the title of Scholar, and to the Exhibition or Exhibitions so filled up, the name of Scholarship, provided that no exercise by the Provost and Fellows of the power hereby given shall affect the conditions of tenure hereinbefore expressed with respect to such Exhibitions."
