Sunken Rock off Cass Spit.

THE Chinese Government has given notice of the existence of a sunken rock lying near the south-eastern extreme of Cass Spit, about 5 cables from Sung Seu Island, western approach to Amoy Inner Harbour :-

This rock, on which the German brig "Minerva" touched in September, 1885, is rugged and uneven, about 150 yards long, in a north-west and southeast direction, and 60 yards in breadth, with a depth of 6 feet at low water spring tides on the shoalest part near its south-east end), and about 4 fathoms around.
