such person shall be deemed a rogue and a vagabond within the meaning of "The Ordinance to enable certain Offences to be tried in a Summary Manner, Gibraltar, 1885," and shall be liable upon conviction before the Captain of the Port to the like punishment as if he had been convicted under that Ordinance.

11. It shall be lawful for any such Constable as aforesaid, at any time between the first morning and the first evening gunfire, to enter any ship, hulk, or boat being within the port and anchorage ground of Gibraltar and to search the same for any gunpowder, arms, or ammunition that may be there secreted or deposited for any unlawful purpose or suspected so to be, and such gunpowder, arms, or ammunition to seize and remove to any such place as shall for that purpose be appointed by the Governor; and such gunpowder, arms and ammunition shall be forfeited to Her Majesty; and the owner of any such ship, hulk or boat, as the case may be, shall be liable to a penalty not exceeding 2,500 pesetas.

Rules and Regulations.

12. It shall be lawful for the Captain of the Port from time to time to make and when made to alter and revoke all such regulations in writing as he may deem expedient for the government and use of the port and harbour of Gibraltar and of all ships, hulks, and boats being therein; and for the guidance of the Constables appointed under this Order in the due discharge of their duties; and for the suspension or dismissal or punishment by fine or imprisonment, as occasion may require, of any Constable; and generally for the good order, discipline, and government of such Constables.

13. All such regulations shall be subject to the approval of the Governor and when so approved shall be in force from the date at which they are promulgated as if they had been herein enacted. All such regulations shall be published in the Gibraltar Chronicle and shall be exhibited in one or more conspicuous positions at the Port Office.

14. Any person contravening any rule or regulation for the time being in force under this Order shall be liable to such fine or penalty as may be fixed by any rule or regulation made under

the provisions of this Order.

15. All fines, penalties and forfeitures imposed by this Order, or by any rule or regulation made by this Order, shall be recovered in a summary manner and subject to the provisions contained in "The Ordinance to improve the Administration of the Law by Justices out of Sessions, Gibraltar, 1867," which said Ordinance hereby is and shall be decined and taken to all intents and purposes to be incorporated with and shall be read as part of this Order.

16. The Governor may, if he shall so think fit, remit any fine imposed under any of the provisions of this Order, or any portion thereof. The Governor may also, upon the recommendation of the Captain of the Port, sanction the payment to an informer of a moiety or any less part of any

fine imposed under this Order.

17. All fines and penalties recovered under this Order, save and except such portion thereof as may have been paid to any informer under the authority of the last preceding section, shall be paid into the Colonial Treasury for the use of Her Majesty, Her heirs and successors.

Hulks.

18. No hulk as defined by this Order shall be permitted to remain within the port, harbour or anchorage ground of Gibraltar except by the license of the Governor, and any person desiring

said port, harbour or anchorage ground, shall make application for the same, in writing, to the Governor, through the Captain of the Port; anything in the Revenue Order in Council, Gibraltar, 1884, to the contrary notwithstanding, and it shall be in the discretion of the Governor to grant or to refuse such license in each particular case as to him may seem meet, and to introduce into every license such conditions as to him, from time to time, shall seem necessary or ex-

A license may be granted for any period not exceeding twelve calendar months from the day of the date thereof, anything in the Revenue Order in Council, Gibraltar, 1884, to the contrary notwithstanding, and every license shall be resumable by the Governor at his pleasure, and shall be absolutely forfeited by the violation or wilful neglect of any of the terms and conditions thereof; no license shall be of any force or effect until the same has been duly registered in the office of the Captain of the Port, in a book to be provided and kept by him for that purpose, and for registering any such license the Captain of the Port shall be entitled to receive the sum of 6 pesetas and 30 centimos and no more.

19. There shall be paid for every such license as aforesaid the fee mentioned in the Schedule marked "A" to the Revenue Order in Council,

Gibraltar, 1834, attached.

20. If any hulk shall remain within the port, harbour or anchorage ground of Gibraltar without a license for that purpose first had and obtained from the Governor, or shall remain therein after the expiration, resumption or forfeiture of any license, or while any liceuse is not actually in force, then, and in any or either of the cases aforesaid, the owner or master of such hulk shall, on conviction, be liable to pay a fine not exceeding 500 pesetas for every day during which the same shall so remain in the said port, harbour or anchorage ground.

21. Any falucho, lighter or other vessel or boat of any description as defined by this Order found pulling or sailing about, being towed, drifting or moving during the period intervening between the following times, namely forty minutes after the first evening gunfire on any day and the time of morning gunfire on the following day, except whilst entering the port in the prosecution of a bonâ fide voyage for the purpose of taking up a berth, or except with the permission in writing of the Captain of the Port, or except in case of necessity to be allowed by him, the owner or other person having charge thereof shall be liable to pay a fine not exceeding 2,500 pesetas.

22. If any falucho, lighter or other vessel or boat of any description having cleared and moved from the port or from her former anchorage, or having in any manner with or without clearing left the port or her former anchorage, shall loiter either outside or inside the port and again cast anchor in the port, or make fast to any hulk or boat, except with the permission, in writing, of the Captain of the Port, or in case of necessity to be allowed by him, the owner or other person having charge thereof shall be liable for every such offence to pay a fine not exceeding 2,500 pesetas.

23. If any ship, hulk or boat shall from any cause be sunk in the port or harbour of Gibraltar, and the owner or master thereof shall fail to remove the same within 14 days, or within such further time as the Captain of the Port may fix, after such owner or master shall have been required in writing by the Captain of the Port so to do, it shall be lawful for the Captain of the to obtain a license for any hulk to remain in the | Port to remove such ship, hulk, or boat, and the
