THE Board of Trade have received through the Secretary of State for the Colonies copies of the two following Notices, extracted from the Cyprus Gazette:—

## No. 4.—Quarantine Notices.—Cholera.

UNDER the powers vested in him by "The Quarantine Ordinance, 1879," His Excellency the High Commissioner is pleased to direct that—

1. All vessels arriving in any port or part of Cyprus, except Larnaca, from Trieste, which left after the 7th of June, without having performed quarantine at an intermediate port, shall be repelled.

2. All arrivals at Larnaca from Trieste, which left after the 7th of June, shall undergo a quarantine of five clear days.

3. Passengers' baggage and merchandize must be landed in quarantine to undergo the disinfection considered necessary. Rags are to be repelled; non-susceptible merchandize shall not be liable to quarantine.

4. Mails arriving direct therefrom will be landed in quarantine, disinfected, and delivered
