(No. 168.)—Norway—South and South-West COASTS.—LAURVIK FIORD ENTRANCE.

(1.) Svenöer Island Lighthouse-Sector of Red Light.

THE Norwegian Government has given notice, that on 15th July, 1886, a sector of red light would be exhibited from Svenöer Island Lighthouse, eastern side of entrance to Laurvik Fiord:-

This sector of red light is shown over the outer part of Rakkeboerne Shoals, between the bearings of N. 79½° E. (leading one cable southward of South Skalberghausen) and S. 874° E. (leading two cables southward of Herregaardsboen,

one of the northern patches).

Note.—Vessels keeping southward of the sector of red light will pass southward of Rakkeboerne Shoals, with the exception of E. Skalberghausen, which has a depth of twelve fathoms; keeping within the sector of red light, the best depths will be carried over Rakkeboerne Shoals, but these can only be crossed by small vessels, and with smooth water.

(2.) Staværnsö Light-Re-exhibited, with Alteration in Character.

Also, with reference to Notice to Mariners, No. 24 (1), of 28th January, 1886, on the intended temporary discontinuance and alteration in character of Staværnsö Light, western side of entrance to Laurvik Fiord :-

Further notice has been given, that on 15th July, 1886, the light would be re-exhibited; and is visible between the bearings of N. $56\frac{1}{4}$ ° E. (leading four cables eastward of Tvesteen), through north and west, and S. 51° W. (leading one cable eastward of Agnœs Rock in Laurvik Fiord). It should be seen in clear weather from a distance of eleven miles.

In the fairways the light shows fixed white, in other directions it shows either a flashing light or a fixed red light, in the following manner:

1. A flashing white light over Rakkeboerne Shoals, from N. 56° E. to N. 2½° E. (leading one cable eastward of East Skalberghausen).

2. A fixed white light in the channel between Rakkeboerne Shoals and Svenöer, from N. 21° E.

to N. 313° W.

3. A fixed red light over Svenöer and Rauör with surrounding shoals, from N. 313° W. (leading 1½ cables westward of Dybe Svenörskaten) to N. 80¾° W. (leading a quarter of a cable northward of Seiboen, and three cables northward of the South-eastern Shoal).

4. A fixed white light in Svenöer Channel, from N. 803° W. to N. 833° W.
5. A flashing white light from N. 833° W. (leading one cable southward of Blyroeva Shoal) to S. 434° W. (leading half a cable northward of Sundskjærene in Viks Fiord).

6. A fixed white light from S. 43\frac{1}{4}\times W. to S. 5\frac{1}{4}\times W.
