owner of the horse, ass, or mule, and the person for the time being in charge thereof, shall, each according to and in respect of his own omissions, be deemed guilty of an offence against the Act of 1878.

(4.) If anything is omitted to be done as regards cleansing or disinfection in contravention of a Regulation of the Local Authority made under the authority of this Order, the owner and the lessee and the occupier of any place or thing in or in respect of which,—and the person using the van or other vehicle in which,—and the owner and the charterer and the master of the vessel in which,—(as the case may be,) the same is omitted, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1878.

(5.) If a person in charge of horses, asses, or mules being moved, where, under a Regulation made by the Local Authority under the provisions of this Order, a Movement Licence is necessary, on demand made under this Order, fails to give his true name and address, or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1878. THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1878, and of every other power enabling them in this behalf, and with reference especially to Article 89 of The Animals Order of 1884, do hereby license the Local Authority for the county of Wilts to dig up or cause to be dug up, within fourteen days after the date of this License, the carcases of certain swine which have recently been slaughtered on account of swine-fever, and were buried in a certain six foot well in the rear of the Angel Hotel, in the town of Wootton Bassett, in the county of Wilts, subject to the following conditions :

- 1. The carcases shall be dug up in the presence of, and under the superintendence of, an officer specially appointed in that behalf by the Local Authority.
- 2. The carcases dug up shall be, as far as practicable, covered with quick lime, and shall then be removed from the said well in the rear of the Angel Hotel, and shall be re-buried in the presence of, and under the superintendence of, the said officer, as soon as possible in some proper place, and shall be covered with a sufficient quantity of quick lime or other disinfectant, and with not less than six feet of earth.
- 3. The expenses of and incidental to the digging up, removal, and burial of the carcases shall be defrayed by the Local Authority.
- 4. This License is revocable by the Privy Council. C. L. Peel.

The following Area declared by Order of Council dated the second day of December, one thousand eight hundred and eighty-five, to be an Area infected with swine-fever (namely),—the Petty Sessional Division of Kibbor, in the county of Glamorgan,—is, except such portions thereof as are included in the Areas described in Article 2 of this Order, hereby declared to be free from swine-fever, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. The following Areas (namely),--(1.) the yards and buildings in the occupation of Richard Wadley, at Tynycae, Whitchurch, in the Petty Sessional Division of Kibbor, in the county of Glamorgan; and (2.) the yards and buildings in the occupation of Thomas Evans, at New House Farm, St. Fagans, in the Petty Sessional Division of Kibbor, in the county of Glamorgan,--shall continue to be and are hereby declared to be Areas infected with swine-fever.

3. This Order shall take effect from and immediately after the twenty-eighth day of July, one thousand eight hundred and eighty-six.
