of twenty-nine chains or thereabouts to its junction near Jockey's Farm aforesaid with the public footpath which leads to the house called or known as Bullfinches, and extending thence first eastward and then south-eastward along the middle of the said public footpath for a distance of thirty-one chains or thereabouts (thereby crossing Mott's Mill Stream and skirting the south-western edge of Rocks Wood) to the boundary which divides the said parish of Withyham from the new parish of All Saints Crowborough aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester. The QUEEN's Most Excellent Majesty in Council. W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirteenth and fourteenth years of Her Majesty, chapter forty-one, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-second day of July, in the year one thousand eight hundred and eighty-six, in the words and figures following, that is to say :--

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the thirteenth and fourteenth years of Your Majesty chapter forty-one, and of the Act of the nineteenth and twentieth years of Your Majesty chapter fifty-five have prepared and now humbly lay before Your Majesty in Council the following scheme for setting out and constituting a district for spiritual purposes and annexing such district to the consecrated church of Saint Agnes Birch situate within the limits of the new parish (sometime a district under the above-mentioned Act of the thirteenth and fourteenth years of Your Majesty chapter forty-one otherwise known as 'The Parish of Manchester Division Act 1850') of Saint James Birch-in-Rusholme within the original limits of the said parish of Manchester in the county of Lancaster and in the diocese of Manchester.

"Whereas it appears to us to be expedient that a district for spiritual purposes comprising a portion of the said new parish of Saint James Birch-in-Rusholme and also portions of the new parish of Saint Peter Levenshulme and of the new parish of Saint John Longsight (both which lastnamed new parishes are within the original limits of the said parish of Manchester and were sometime districts under 'The Parish of Manchester Division Act 1850' as aforesaid) should be set out and constituted for and annexed to the said church of Saint Agnes Birch which church was not consecrated under the provisions of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven.

"Now therefore with the consent of the Right divides the township of Rusholme from the town-Reverend James Bishop of the said diocese of ship of Levenshulme) to the point at Nico Ditch

Manchester testified by his having signed and sealed this scheme we the said Ecclesiastical Com-. missioners humbly recommend and propose that all those portions of the said new parish of Saint James Birch-in-Rusholme of the said new parish of Saint Peter Levenshulme and of the said new parish of Saint John Longsight which are described in the schedule hereunder written and are delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme, be severed and disannexed from such new parishes respectively and shall be set out and constituted for and annexed to the said church of Saint Agnes Birch and shall become and be a district for spiritual purposes and shall be named ' The District of Saint Agnes Birch.'

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or to any of them in accordance with the provisions of the hereinnamed Acts or of either of them or of any other Act of Parliament.

" The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Agnes Birch comprising :----

" All those several contiguous portions of the new parish of Saint James Birch-in-Rusholme, of the new parish of Saint Peter Levenshulme, and of the new parish of Saint John Longsight, all within the original limits of the parish of Man-chester, in the county of Lancaster and in the diocese of Manchester, and all sometime districts under 'The Parish of Manchester Division Act 1850' which said portions of such cures are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said new parish of Saint John Longsight from the new parish of Saint James Birchin-Rusholme aforesaid at the centre of the bridge which carries Birch Hall-lane over Gore Brook and extending thence in a direction a little to the east of the south and in a straight line for a distance of seventy-four chains or thereabouts to a point in the middle of Cringle Brook otherwise called or known as Black Brook, distant eleven chains or thereabouts measured along the course of the same brook to the west of the centre of the bridge or culvert which carries Slade-lane over such brook such point being the point where the boundary which divides the new parish of the Holy Innocents Fallowfield (also within the original limits of the parish of Manchester aforesaid) meets the boundary which divides the said new parish of Saint James Birch-in-Rusholme from the new parish of Saint Margaret Burnage (also within the original limits of the parish of Manchester aforesaid) and extending thence eastward for a distance of eleven chains or thereabouts along the last-mentioned boundary (thereby following the course of the last-named brook) to the point at the centre of the bridge or culvert which carries Slade-lane over such brook as aforesaid at which point the said last-mentioned boundary joins the boundary dividing the said new parish of Saint James Birch-in-Rusholme from the new parish of Saint Peter Levenshulme aforesaid and extending thence northward along the last-mentioned boundary for a distance of fifty chains or thereabouts (thereby following the middle of Slade-lane aforesaid, and also following the boundary which divides the township of Rusholme from the town-
