formance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that so long as the Reverend Robert Ross Clerk in Holy Orders the present vicar or incumbent of the vicarage of the said new parish of Forest Gate shall continue to be such vicar or incumbent all the fees which may be received in respect of such publication solemnization or performance at the said church of All Saints situate as aforesaid shall be paid over by the said minister thereof to the said Robert Ross; and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any see for the performance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty

in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference;

"The District Chapelry of All Saints Forest

Gate being:---

"All that part of the new parish (sometime consolidated chapelry) of Forest Gate in the county of Essex and in the diocese of Saint Albans which is bounded upon the north by the parish of Wanstead upon the east by the parish of Little Ilford upon the south by the parish of East Ham all in the county and diocese aforesaid and upon the remaining side that is to say upon the west by an imaginary line commencing upon the boundary which divides the said parish of East Ham from the new parish of Forest Gate aforesaid at the point in the middle of Gipsy-lane, near to the junction of the said lane with the road forming the southern entrance to Saint George's-square and called or known as 'the Terrace,' where the said boundary bends sharply towards the east and extending thence that is from the same boundary northward along the middle of the said Gipsy-lane for a distance of thirty chains or thereabouts to its junction with Romford-road, and extending thence eastward along the middle of the last-named road for a distance of sixteen chains or thereabouts to its junction with Balmoral-road and extending thence northward along the middle of the last-named road for a distance of seventeen chains or thereabouts to its junction with Hamptonroad and with the roadway leading to and across the bridge over the line of the Great Eastern Railway to Sebert-road and Tylney-road and continuing thence that is from the last-described point of junction northward along the middle of the last-described roadway for a distance of six chains or thereabouts to its junction with Sebertroad and with 'I'ylney-road as aforesaid and continuing thence still northward along the middle of the said Tylney-road, for a distance of eighteen chains or thereabouts to its junction with Capelroad and continuing thence still in precisely the same direction that is northward in a straight line for a distance of three and a half chains or thereabouts thereby crossing the last-named road to the boundary on Wanstead Flats which boundary divides the said new parish of Forest Gate from the parish of Wanstead aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in

law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Saint Alban's.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the twenty-ninth day of July, in the year one thousand eight hundred and eighty-six, in the words following, that is to say:—

say:—
"We the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Your Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Your Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Your Majesty, chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint John Sidcup in the county of Kent and in the diocese of Canterbury.

"Whereas by the authority of an instrument bearing date the seventh day of October in the year one thousand eight hundred and forty-four and being under the common seal of Your Majesty's late Commissioners for building new churches and being also under the hand and episcopal seal of the then Bishop of the diocese of Rochester, within which diocese the parish of Chislehurst in the said county of Kent was then situate, a certain portion of the said parish of Chislehurst was assigned as a particular district to the consecrated church of Saint John situate at Sideup in the same parish.

"And whereas under the authority of an Order of Your Majesty in Council bearing date the eighth day of August in the year one thousand eight hundred and forty-five and published in the London Gazette on the twentieth day of the same month the said parish of Chislehurst and the said particular district of Saint John Sidcup were, together with certain other cures transferred from the said diocese of Rochester to the diocese of

Canterbury aforesaid.

"And whereas under the authority of another Order of Your Majesty in Council bearing date the twentieth day of March in the year one thousand eight hundred and sixty - three the boundaries of the said particular district of Saint John Sideup were altered by the addition thereto of a portion of the parish of Foots Cray in the said county of Kent and in the diocese of Canterbury aforesaid, and by the transference to the said parish of Foots Cray of a portion of the particular district of Saint John Sideup aforesaid.

"And whereas the said particular district of Saint John Sidcup has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four
