An Area in the Eastern Division of the county of Sussex, comprised within the following boundaries, that is to say, commencing in Ticehurst village at the entrance to the lane there called Pickford-lane past Pickford House down Tinkerslane into the parish highway leading from Three Legged Cross and along such highway to Overys farm at the bottom of Rosemary-lane, thence by a footpath through Ketly Wood to Quedley farm, thence by the occupation-road to Little Gibsread farm and along the northern boundary of the main-road there to the said Pickford-lane in Ticehurst village aforesaid.

(SWINE-FEVER.)

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Areas (namely),—(1.) the yards and buildings in the occupation of Richard Wadley, at Tynycae, Whitchurch, in the Petty Sessional Division of Kibbor, in the county of

Glamorgan ; and (2.) the yards and buildings in the occupation of Thomas Evans, at New House Farm, St. Fagans, in the Petty Sessional Division of Kibbor, in the county of Glamorgan,—which were declared by Order of Council to be Areas infected with swine-fever, are hereby declared to be free from swine-fever, and those Areas shall, as from the commencement of this Order, cease to be Areas infected with swine-fever.

2. This Order shall take effect from and immediately after the twenty-eighth day of October, one thousand eight hundred and eighty-six.

THE ANIMALS ORDER OF 1886, KING-DOM OF NORWAY AMENDMENT.

A T the Council Chamber, Whitehall, the 27th day of October, 1886.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1.-(1.) Unless and until the Privy Council otherwise order, animals brought from the Kingdom of Norway shall not be landed in England or Wales or Scotland.

(2.) The Animals Order of 1886 shall be read and have effect as if the Kingdom of Norway was included in the list of Prohibited Countries named in Part I. of the Fourth Schedule to that Order and was not included in the list of Free Countries named in Part I. of the Fifth Schedule to that Order.

2. The following provisions of this Article shall during the continuance of this Order be read in the place of Article 151 of The Animals Order of 1886, and shall be deemed to be Article 151 of that Order (namely):

Conditions of Landing.

151.—(1.) The landing of foreign animals at a Landing-Place for foreign animals under the provisions of this Chapter is subject to the following conditions:

First. That the vessel in which they are imported has not, within twenty-eight days before taking them on-board, had on board any animal exported or carried coastwise from a port or place in any country other than in Her Majesty's Possessions in North America, or in Iceland, or in New Zealand, or in the Channel Islands, or in the Isle of Man, or (subject to the second condition of this Article) in Denmark or in Sweden.

- Second. That the vessel in which they are imported has not, within twenty-eight days before taking them on board, had on board any swine exported or carried coastwise from a port or place in Denmark or in Sweden.
- Third. That the vessel has not within twentyone days before taking them on board or at any time since taking on board the animals imported, entered any port or place in any country other than in Her Majesty's Possessions in North America, or in Iceland, or in New Zealand, or in the Channel Islands, or in the Isle of Man, or in Denmark, or in Sweden, or in the United States of America.
- Fourth. That the animals imported have not, while on board the vessel, been in contact with any animal exported or carried coastwise from any port or place in any country other than in Her Majesty's Possessions in North America, or in Iceland, or in New Zealand, or in the Channel Islands, or in the Isle of Man, or (subject to the fifth condition of this Article) in Denmark or in Sweden.
- Fifth. That the animals imported have not while on board the vessel been in contact with any swine exported or carried coastwise from a port or place in Denmark or in Sweden.

(2.) And the animals imported shall not be landed at a Landing-Place for foreign animals unless and until-

- (a.) The owner or charterer of the vessel in which they are imported, or his agent in England or Wales or Scotland, has entered into a bond to Her Majesty the Queen, in a sum not exceeding one thousand pounds, with or without a surety or sureties, to the satisfaction of the Commissioners of Customs, conditioned for the observance of the foregoing conditions; and
- (b.) The master of the vessel has on each occasion of importation of foreign animals therein satisfied the Commissioners of Customs, or their proper officer, by declaration made and signed or otherwise, that all the animals then imported therein are properly imported according to the provisions of this Article.

3. In this Order terms have the same meaning as in The Animals Order of 1886.

4. This Order may be cited as THE ANIMALS ORDER OF 1886, KINGDOM OF NORWAY AMEND-MENT.

5. This Order shall commence and take effect from and immediately after the thirty-first day of October, one thousand eight hundred and eighty-six,

SOLDIERS' BALANCES UNCLAIMED.

IN pursuance of the "Regimental Debts Act, 1863," notice is hereby given, that Her Majesty's Principal Secretary of State for the War Department has available, for distribution amongst the Next of Kin or others entitled, the sum of money set opposite to the name of each of the deceased soldiers named in the list which is published with this notice in the London Gazette, and the "Army List," and is also to be seen at the Regimental Districts and at the Quarters of the several Statf Officers for the Pension Service throughout the United Kingdom.

Applications from persons supposing themselves entitled as Next of Kin should be addressed by letter to "The Under Secretary of State, War Office, London, S.W.," and marked outside "Soldier's Effects."

No application can be attended to which does not state the date and place of the soldier's birth, enlistment, and death, and the name of his regiment; his regimental number should also be stated if known.

Should these particulars furnished by the applicant not agree with the facts recorded on the War Office documents relating to the deceased soldier, the applicant will be so informed; but should they agree therewith, then within three calendar months the Secretary of State will furnish the applicant with the usual requirements needed for the proof of the alleged relationship.

The application must be authenticated by the signature of the applicant, and his name should be affixed in the presence of the clergyman, or one of the churchwardens of the parish, or a Justice of the Peace; the applicant's address, with the name of the post town, must also be clearly stated. No personal application can receive attention.

Further lists will from time to time be published, and therefore it will facilitate the applicant's inquiries to give the number and date of the notice in which the deceased soldier's name appeared. By order of the said Principal Secretary,


