THE Queen has been pleased, under Her Majesty's Royal Sign Manual and the Great Seal to declare Her Royal will and pleasure, that the sons and daughters born of the marriage of His Royal Highness Prince Henry Maurice of Battenberg with Her Royal Highness Princess Beatrice Mary Victoria Feodore shall at all times hold and enjoy the style, title, and attribute of "Highness" prefixed to their respective Christian names or any titles of honour which may belong to them: and further to declare Her will and pleasure, that the Earl Marshal of England do see this declaration kept, and cause the same to be duly registered in Her Majesty's College of Arms, to the end that the officers of arms, and all others upon occasion, may take full notice and have knowledge thereof.

(PLEURO-PNEUMONIA.)

AT the Council Chamber, Whitehall, the 13th day of December, 1886.

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the fifteenth day of December, one thousand eight hundred and eighty-six.

SCHEDULE.

An Area in the county of Chester, comprised within the following boundary, that is to say, from the junction of the Warrington and Northwich-road at Stockton Heath to Kinder's Smithy, from thence by Ashworth's-lane and occupation-road by Whitley reed by Had's Nook to Swinyard-lane, Swinyard-lane to Knutsford high-road, by Knutsford high-road to the "Dog and Dart," Grappenhall, and thence by the Chester and Altrincham high-road to Stockton Heath aforesaid.

(PLEURO-PNEUMONIA.)

By Her Majesty's Most Honourable Privy Council.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—in the county of Warwick, comprising all the lands and buildings lying between a line drawn from the Beggars Well on the Coleshill and Tamworth-road to the point where the Gossey-lane enters the said Coleshill and Tamworth-road, thence along the Gossey-lane to the Forge Mills Railway Station, thence along the Midland Railway to the Jack O'Watton Railway Bridge, thence along the Coleshill and Tamworth-road to the point where the Jack O'Watton-lane leads to Water Orton, thence along the Jack O'Watton-lane to the Green-lane leading into the main-road from Water Orton to Coleshill, and thence along the Water Orton and Coleshill main-road to the Beggars Well: the said roads (excepting the main-road from Coleshill to Water Orton) being included in the Area,—which was declared by Order of Council dated the sixteenth
