

described in the schedule hereunder written, a' which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Mark situate as aforesaid, and that the same should be named 'The District Chapelry of Saint Mark Saint Helens.'

"And with the like consent of the said John Charles Bishop of the said diocese of Liverpool (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Mark situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always, that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Mark, Saint Helens, being:—

"All that part of the parish of Saint Helens in the county of Lancaster and in the diocese of Liverpool, wherein the present incumbent of such parish still possesses the exclusive cure of souls, which is bounded upon the north-west by the new parish of All Saints Rainford, upon the north-east by the chapelry of Billinge in the parish of Wigan, upon the east partly by the new parish of Saint James Haydock and partly by the new parish of Saint Peter Parr and upon the south partly by the new parish of the Holy Trinity Parr Mount all in the said county of Lancaster and in the diocese of Liverpool aforesaid, and upon all other sides that is to say upon the remaining part of the south and upon the west by an imaginary line commencing upon the boundary which divides the said new parish of the Holy Trinity Parr Mount from the parish of Saint Helens aforesaid at the point where the Saint Helens Canal is joined by the Gerard's Bridge Branch of the same canal and extending thence westward along the middle of the said branch canal for a distance of seventeen and a half chains or thereabouts to the centre of the bridge which carries the line of the Rainford Branch of the London and North-Western Railway over the same branch canal and extending thence northward along the middle of the said bridge for a distance of thirty feet or thereabouts to a point over the middle of the towing-path on the northern bank of the said branch canal and extending thence for a distance of seven chains or thereabouts first westward and then north-westward along the middle of the said towing-path and along the middle of the occupation-road which leads from such towing-path into Gerard's-street, to the junction of the said occupation-road with the said street and extending thence south-westward along the middle of the same street for a distance of twenty and a half chains or thereabouts to its junction with Peel-street and extending thence north-westward along the middle

of the last-named street for a distance of five chains or thereabouts to its junction with Oldfield-lane and Cooper-street and extending thence westward along the middle of the last-named street for a distance of twenty-seven chains or thereabouts to its junction with Cowley Hill-lane and extending thence first northward then north-westward and then north-eastward along the middle of the last-named lane for a distance of fifty-three chains or thereabouts to its junction at the Hope and Anchor Corner, with City-road and with the road or lane leading in continuation of City-road aforesaid into Hard-lane and extending first northward and then north-westward along the middle of the said road or lane for a distance of fifteen chains or thereabouts to its junction with Hard-lane aforesaid and extending thence eastward along the middle of the last-named lane for a distance of two chains or thereabouts to its junction with the roadway and footpath leading past the house called or known as Brown's Fold over Rainford Brook towards the Mossbank Railway Station and extending thence that is from Hard-lane aforesaid north-eastward along the middle of the last-described roadway and footpath for a distance of ten chains or thereabouts to the centre of the foot-bridge which carries the same footpath over Rainford Brook aforesaid, and extending thence first generally north-westward and then south-westward along the middle of the said brook for a distance of sixty-one chains or thereabouts to the boundary at the junction of the same brook with the stream flowing from Cook's Wood which boundary divides the said parish of Saint Helens from the new parish of All Saints Rainford aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Ecclesiastical Commissioners' Act 1840 Amendment Act 1885 duly prepared and laid before Her Majesty in Council a scheme, bearing date the second day of December, in the year one thousand eight hundred and eighty-six, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England acting in pursuance of 'The Ecclesiastical Commissioners' Act 1840 Amendment Act 1885,' have prepared and now humbly lay before Your Majesty in Council the following scheme for augmenting the income of the Archdeaconry of Ludlow in the diocese of Hereford.

"Whereas it has been made to appear to us that the augmentation hereinafter recommended and proposed is required in order to raise the average annual income of the said Archdeaconry of Ludlow to two hundred pounds.
