wall for a distance of three and three quarter chains or thereabouts (thereby passing to the south of the engine house and pumping station of the said waterworks and along the northern side of the said mission church site and of the said public garden) to the eastern end of the same wall on the south-western bank of the Ravensbourne River and continuing thence still eastward and in a direct line to the boundary in the said river which boundary divides the said new parish of Saint John Deptford from the new parish of the Holy Trinity West Greenwich aforesaid."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrax of the said diocese of Rochester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of "The Ecclesias ical Commissioners' Act 1840 Amendment Act 1855" duly prepared and laid before Her Majesty in Council a scheme, bearing date the sixteenth day of December, in the year one thousand eight hundred and eighty-six, in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England, acting in pursuance of The Ecclesiastical Commissioners' Act 1810 Amendment Act 1885, have prepared and now humbly lay before Your Majesty in Council the following scheme for augmenting the income of the Archdeaconry of Le cester in the diocese of Peterberough.

"Whereas it has been made to appear to us that the augmentation hereinafter recommended and proposed is required in order to raise the average annual income of the said Archdeacoury of Leicester to two hundred pounds.

Now therefore we, the said Ecclesiastical Commissioners for England with the consent of the Right Reverend William Connor Bishop of the said diocese of Peterborough (testified by his having signed and scaled this scheme) humbly recommend and propose that until a canonry in the Cathedral Church of Peterborough shall be annexed to the said Archdeaconry of Leicester there shall be paid by us on the first day of January in every year out of the common fund created by the Act of the third and fourth years of Your Majesty's reign chapter one hundred and thirteen, to the Archdeacon of the said Archdeaconry of Leicester, and to his successors in the same archdeaconry the sum of one hundred and seven pounds in addition to the yearly sum of thirty-eight pounds

now payable by us to the archdeacon for the time being of the said archdeaconry under and by virtue of an Order of Your Majesty in Council dated the twenty-eighth day of July in the year one thousand eight hundred and sixty-four, and published in the London Gazette of the second day of August in the same year.

'And we further recommend and propose that the first payment of the said yearly sum of one hundred and seven pounds so hereby recommended to be made as aforesaid shall be made on the first day of January in the year one thousand eight hundred and eighty-seven, and that every such payment as well as the said yearly payment of thirty-eight pounds hereinbefore mentioned shall be made by us only after we shall have been satisfied that the archdeacon who applies for the same has during the previous twelve calendar months complied with the conditions as to residence which for the time teing are required by law and that both of such yearly payments shall be apportionable between any archdeacon resigning or otherwise avoiding the said archdeacoury or his representatives (as the case may be) and the archdeacon who shall next be collated to the same archdeaconry.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the herein-before mentioned Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Peterborough.

BATH.-Forthwith and entirely in the Baptist Chapelyard Lyncombe Hill, Bath, in the county of Somerset, except as follows:—
