THE Queen has been pleased to grant unto Sir John Robert Laurie Emilius Bayley, of Maxwelton House, in the shire of Dumfries, and of Hyde Park-street, in the parish of Paddington, in the county of Middlesex, Baronet, Bachelor of Divinity, and Vicar of Saint John's, in the said parish of Paddington, eldest son and heir of Sir John Edward George Bayley, Baronet, by Charlotte Mary, his wife, second daughter of John Minet Fector, late of Dover, in the county of Kent, Esquire, and Anne Wortley Montague, his wife, only sister and heir of Sir Robert Laurie, late of Maxwelton aforesaid, Baronet, Admiral in Her Majesty's Navy, and Knight Commander of the Most Honourable Order of the Bath, all deceased, Her Royal licence and authority that, in compliance with a clause contained in a certain deed of disposition executed by Isabella Laurie (formerly Isabella Murray, Spinster), of Maxwelton aforesaid, Widow, relict of John Minet Laurie (formerly John Minet Fector, who was the maternal uncle of the said Sir John Robert Laurie Emilius Bayley), late of Maxwelton aforesaid, Esquire, deceased, he may henceforth assume and constantly hereafter bear and use the surname, title, designation, and arms of Laurie of Maxwelton as his proper surname, title, designation, and arms, and that such surname and arms of Laurie of Maxwelton may be in like manner taken, borne, and used by his issue, such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Representative at Stockholm, stating that the Swedish Board of Trade have published a notice, dated 22nd ultimo, to the effect that Sierra Leone is free from yellow fever.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Representative at Monte Video, stating that the absolute embargo on all communication whatsoever between the Uruguayan and Argentine ports established early in November last on account of supposed Asiatic cholera was taken off, and a quarantine of 21 days substituted four weeks ago; one of eight days having taken its place a week since; and the period of quarantine from the Argentine to the Uruguayan ports being at present fixed at three days; although that from the Uruguayan to the Argentine ports is of five days.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Representative at Lima, stating that the ports in Peru are closed to all vessels which may have touched at ports in Chili subsequently to the 25th of last December. Punta de Arenas is, however, excepted so far that steamers may coal in that port, and if there has been no further communication with the shore will be admitted in the ports of Peru subject to strict sanitary examination.
