Proviso insuper quod pensiones e munificentia Nathanielis Baronis Crewe provenientes Rectori et Sociis modo consueto solvantur, ita ut Rector viginti libras, et Socius quisque decem libras, annuatim percipiat, vel medietatem, si per partem tantum anni locum suum tenuerit; proviso etiam quod pensiones ex eâdem munificentiâ provenientes, si quæ ad locos vacantes pertineant, in cistà speciali reponantur. § 5. "Amendment sanctioned by the Visitor, 14 Nov. 1871.

To enact that in any year in which the ordinary emoluments of a Fellow shall exceed £300, the Rector and four senior Fellows shall be excepted from the aforesaid limitation in the case of any one of them who shall in that year have qualified himself by residence to be a member of the new House of Congregation; and further, to enact that the surplus of Fellowship incomes shall be carried to the credit of the capital fund of Dr. Radford's trust estate for enlarging and improving the buildings of the College, subject, however, to the liability of making good the deficiencies of subsequent years, as provided in the Latin clause (§ 5) of the statute.

A. In order to save existing interests, so long as the existing Rector or any of the existing Fellows remain under the present statutes, the accounts of the Corporate Revenue of the College shall be made out in the form now in use, and the division referred to in § 4 shall be calculated in all respects as if the Rector and all the Fellows were under the present statutes, and the number

of the Fellows the same.

The remainder of the divisible amount shall be apportioned in the following order:—

(i) The sums hereinafter directed to be paid under cap. viii. A, B, C.

(ii) The payment of Fellowships held under the amended statutes.

(iii) Any surplus that remains shall be apportioned as provided in cap. viii. § 1. D, E.

B. Whenever the revenues of the College are not sufficient (after the payment of the charges under cap. viii. § 1. A, B, C) to pay to the

Rector and Fellows the stipends above mentioned the loss shall be borne by them proportionately.

C. Whenever the deficiency in any one year shall exceed £10 per Fellowship, the Rector and Fellows shall have power, with the consent of the Visitor, to suspend, for one year from the date at which it would otherwise be filled up, any Fellowship that falls vacant. Such suspension may be continued for successive years, with the Visitor's consent, until such times as the divisible revenue shall be sufficient for the normal payments.

D. The Rector and Fellows may assign out of the Pension Fund a pension to any Fellow who has served in the capacity of Tutor or Lecturer for at least twenty-five years, or who is prevented by physical or mental infirmity from discharging the duties of his office: Provided that he do not continue to be a Fellow of the College, and that he do not hold any Headship, Professorship, Readership, Tutorship, Lectureship, or Fellowship within the University or any College thereof, and that he do not hold any Ecclesiastical Benefice, or any office, place, or pension amounting to the yearly value of £300: provided also that no payment shall be made out of such fund until the capital of the fund shall reach the sum of £8,000; after which time it shall be lawful to assign a pension not exceeding the annual value of £200.

§ 1. Expedire visum est, quod, quum primum fieri poterit, pecunim in certos usus infra specificatos adhibenda comparentur et reserventur.

A. A certain sum of money shall be paid in each year to the Professor of Classical Archæology and Art, viz., such a sum, as, together with the value of his Fellowship and exclusive of the benefaction

of Lord Crewe, shall amount to £300.

B. There shall be a Tuition Fund, consisting of the sums bequeathed by Dr. Hutchins to the Moderators and Greek Lecturers and the Tuition Fees payable by Undergraduates, to which shall be added in each year from the Corporate Revenue, saving the provisions of chapter 6, a sum not greater than £400. Out of this fund the Rector and Fellows may pay to each Tutor and Lecturer a sum not greater than £100, and in addition they may pay to them and to other persons engaged in the work of instruction in the College such sums as they may determine.

C. There shall be a Scholarship Fund, consisting of the income of the Trust Funds enumerated below, to which shall be added from the Corporate Revenue, saving the provisions of cap. 6, an

annual sum of £200.

D. (a.) A further sum of not more than £200 may be carried each year to the Tuition Fund: and (b.) such further sums, as the Rector and Fellows may from year to year determine, may be carried to the Scholarship Fund.
