Exeter in respect of synodals and a payment of four pounds three shillings and four pence per annum formerly made to the Dean and Chapter of the Cathedral Church of Exeter for pentecostals, are now made to us by the Archdeacon of the said Archdeaconry of Totnes for the time being.

"And whereas it has been made to appear to us that the augmentation hereinafter recommended and proposed is required in order to raise the average annual income of the said Archdeaconry

of Totnes to two hundred pounds.

"Now therefore we the said Ecclesiastical Commissioners with the consent of the Right Reverend Edward Henry Bishop of the said diocese of Exeter (testified by his having signed and sealed this scheme) humbly recommend and propose that the said two yearly payments of one pound thirteen shillings and four pence and four pounds three shillings and four pence hereinbefore specified shall as from the first day of January in the year one thousand eight hundred and eighty-six cease and determine and that the same shall as from that day no longer be payable by the Archdeacon of the said Archdeaconry of Totnes.

"And we further recommend and propose that we be authorized to pay on the first day of January in every year out of the common fund created by the Act of the third and fourth years of Your Majesty's reign chapter one hundred and thirteen to the Archdeacon of the said Archdeaconry of Totnes and to his successors in the same archdeaconry the sum of eight pounds in addition to the yearly sum of one hundred and sixty-two pounds now payable by us to the archdeacon for the time being of the said archdeaconry under and by virtue of an Order of Your Majesty in Council, dated the first day of August in the year one thousand eight hundred and sixty and published in the London Gazette of the third day of the same month.

"And we further recommend and propose that the first payment of the said yearly sum of eight pounds so hereby recommended to be made as aforesaid shall be made in respect of the year ended the first day of January one thousand eight hundred and eighty-seven and that every such payment as well as the said yearly payment of one hundred and sixty-two pounds hereinbefore mentioned shall be made by us only after we shall have been satisfied that the archdeacon who applies for the same has during the previous twelve calendar months complied with the conditions as to residence which for the time being are required by law and that both of such yearly payments shall be apportionable between any archdeacon resigning or otherwise avoiding the said archdeaconry or his representatives (as the case may be) and the archdeacon who shall next be collated to the same archdeaconry.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the herein-before mentioned Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the Acts mentioned

n the said scheme; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Exeter.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of "The Ecclesiastical Commissioners' Act 1840 Amendment Act 1885" duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-fourth day of February, in the year one thousand eight hundred and eighty-seven, in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England acting in pursuance of 'The Ecclesiastical Commissioners' Act 1840 Amendment Act 1885' have prepared and now humbly lay before Your Majesty in Council the following scheme for augmenting the income of the Archdeaconry of Barnstaple in the diocese of Exeter.

"Whereas two annual payments, being a payment of nine pounds per annum formerly made to the Bishop of Exeter in respect of synodals, and a payment of five pounds formerly made to the Dean and Chapter of the Cathedral Church of Exeter for Peter's Farthings, are now payable to us by the Archdeacon of the said Archdeaconry of Barnstaple for the time being.

"And whereas it has been made to appear to us that the augmentation hereinafter recommended and proposed is required in order to raise the average annual income of the said Archdeaconry

of Barnstaple to two hundred pounds.

"Now therefore we the said Ecclesiastical Commissioners with the consent of the Right Reverend Edward Henry Bishop of the said diocese of Exeter (testified by his having signed and sealed this scheme) humbly recommend and propose that the said two yearly payments of nine pounds and five pounds hereinbefore specified shall as from the first day of January in the year one thousand eight hundred and eighty-six cease and determine and that the same shall as from that day no longer be payable by the Archdeacon of the said Archdeaconry of Barnstaple.

"And we further recommend and propose that we be authorized to pay on the first day of January in every year out of the common fund created by the Act of the third and fourth years of Your Majesty's reign, chapter one hundred and thirteen to the Archdeacon of the said Archdeaconry of Barnstaple and to his successors in the same archdeaconry the sum of thirteen pounds in addition to the yearly sum of one hundred and eighteen pounds now payable by us to the archdeacon for the time being of the said archdeaconry under and by virtue of an Order of Your Majesty in Council dated the nineteenth day of March in the year one thousand eight hundred and sixty-seven, and published in the London Gazette of the twenty-second day of the same month.

"And we further recommend and propose that the first payment of the said yearly sum of thirteen pounds so hereby recommended to be made as aforesaid shall be made in respect of the year ended the first day of January one thousand eight hundred and eighty-seven and that every such payment as well as the said yearly payment of one hundred and eighteen pounds hereinbefore mentioned shall be made by us only after we shall have been satisfied that the archdeacon who
