the ten days immediately preceding the date of their embarkation.

2. Vessels arriving from Sicily, or which have been in a Sicilian port within ten days, will, provided all are well on board and they bring no passengers from Sicily, be allowed to discharge and take cargo in quarantine.

3. Vessels which have left Sicily more than ten days before arrival in Malta will, provided all are well on board and they bring no passengers from Sicily, be admitted in free pratique.

4. Vessels arriving from Sicily, and admitted to discharge or load under Section 2 of this Notice, will, at the expiration of ten days from the date of leaving Sicily, be admitted to pratique, subject however to medical inspection and thorough disinfection.

5. Susceptible goods from Sicily will not be allowed to be landed.
