

" 6. All that small detached portion of the parish of Sykehouse situated within the boundaries of the parish of Thorne and bounded on or towards the west by Moor End-road and on or towards the east by Moor Drain.

" 7. All that small detached portion of the parish of Sykehouse situated within the boundaries of the parish of Thorne bounded on the east by March-lane and on the south by Hadd's Nook-road and numbered 10 on the annexed plan.

" 8. All that detached portion of the parish of Sykehouse immediately adjoining the said parish of Thorne and bounded on or towards the north-east and south by that parish and on or towards the west by the River Don.

" 9. All that detached portion of the parish of Sykehouse comprising lands known as Johnny Moor Long and part of Reedholme Common and bounded on or towards the north partly by a detached portion of the parish of Thorne and partly by the township of Rawcliffe on or towards the east by the main body of the said parish of Thorne and the Moor Ends-road on or towards the south partly by the said parish of Thorne and partly by a detached portion of the parish of Fishlake more particularly described in the third schedule to this scheme and on or towards the west by the River Don.

" 10. All that small detached portion of the parish of Sykehouse immediately adjoining the parish of Thorne bounded on or towards the west by Moor Ends-road and numbered 1 on the plan hereto annexed.

" All which said portions of the parish of Sykehouse are particularly delineated on the said plan hereto annexed and thereon coloured round with a blue verge line."

" The THIRD SCHEDULE before referred to.

" 1. All that detached portion of the parish of Fishlake situated within the boundaries of the said parish of Thorne and bounded on the north by the South Soak Drain and on or towards the south and south-east by the Brierholme Carr Drain and numbered 22 on the annexed plan.

" All those two small detached portions of the parish of Fishlake immediately adjacent to the above and numbered 20 and 21 on the same plan respectively.

" 2. All that detached portion of the parish of Fishlake situated within the boundaries of the parish of Thorne north of the Stainforth and Keadby Canal near Pashley or Wike Bridge and bounded on or towards the west by Wikegate-road and on or towards the east by lands known as Wikegate and numbered 16 on the said plan.

" 3. All that detached portion of the parish of Fishlake immediately adjoining the said parish of Thorne and bounded thereby on the east and south sides thereof and on the west and north by lands known as Balncroft and Stainforth-lane Closes, and numbered 17 on the said plan.

" 4. All that detached portion of the parish of Fishlake immediately adjoining the said parish of Thorne and bounded thereby on the east south and west and by the detached portion of the parish of Sykehouse particularly described in the second schedule to this scheme on or towards the north and numbered 13 on the said plan.

" 5. All that detached portion of the parish of Fishlake immediately adjoining the said parish of Thorne and bounded thereby on the south and east by a detached portion of the parish of Hatfield described in the first schedule hereto on the west and by a detached portion of the parish of Sykehouse described in the second schedule hereto on the north which said detached portion of the

parish of Fishlake is numbered 13A on the annexed plan.

" 6. All that detached portion of the parish of Fishlake immediately adjoining the said parish of Thorne and bounded on or towards the north by the said parish of Thorne on or towards the east partly by the said parish of Thorne and partly by the said detached portion of the parish of Sykehouse and the detached portion of the parish of Hatfield described in the first schedule to this scheme and numbered 23 on the annexed plan on or towards the south partly by the said parish of Thorne and partly by the detached portion of the parish of Sykehouse described in the second schedule to this scheme and numbered 12 on the said plan and on or towards the west partly by the said parish of Thorne and partly by the River Don.

" 7. All that detached portion of the parish of Fishlake immediately adjoining the said parish of Thorne and bounded thereby on the east south and west and by the detached portions of the parish of Sykehouse in the second schedule to this scheme described on or towards the north.

" All which detached portions of the parish of Fishlake are particularly delineated on the plan hereto annexed and thereon coloured round with a yellow verge line.
