May it please Your Majesty,

WE, Your Majesty's loyal and dutiful subjects, the Ministers and Elders of the Church of Scotland convened in General Assembly, beg most respectfully to thank Your Majesty for Your Royal letter with its hearty greetings. Your Majesty may rest assured that in all our meetings it will be our great endeavour to promote virtue and piety among the people, as in our daily ministrations we endeavour to teach them their whole duty both to God and their fellow-men. And we rejoice to believe that by the ministrations of the National Church many generations of truly religious men and women have been reared up to do their world's work well, both as citizens of the state and as members of the church, and to make the name of Scotland respected everywhere.

We acknowledge with thankfulness Your Majesty's renewed assurance that You are determined to maintain the Church of Scotland in all its ancient rights and privileges, and that Your Majesty has otherwise bestowed many favours upon it. It will always be our endeavour to show our gratitude and prove that we are worthy

of Your Majesty's favours.

The appointment of the Right Honourable the Earl of Hopetoun as Your Majesty's Representative is peculiarly agreeable to us: his ancient lineage, his high character, his devotion to the Church, all make him eminently suitable to represent the Majesty of the Throne; and His Grace has already gained our confidence and commanded our respect by his condescending and kind manner in the conduct of his Vice-regal post.

We receive with gratitude Your Majesty's gift of two thousand pounds for the diffusion of Christian Knowledge in the Highlands and Islands; and we shall be most careful to spend it in the way best fitted to accomplish the beneficent end which Your Majesty has in view.
