with staff and St. George cross.

3. Bogha Nuadh Buoy, Firth of Forth, will be spherical, red and white horizontal stripes, with staff and St. George cross.

4. Sgeir Rat, S.W. Buoy, Oban Bay, will be spherical, black and white horizontal stripes, with

staff and diamond.

5. Sgeir Rat, N.E. Buoy, Oban Bay, spherical, red and white horizontal stripes, with staff and triangle.

6. Corran Bank, South Buoy, Loch Aber, will be spherical, black and white horizontal stripes,

with staff and diamond.

7. Corran Bank, N.E. Buoy, Loch Aber will be spherical, red and white horizontal stripes, with staff and triangle.

8. Roan Bogha Buoy, Passage of Tiree, will be spherical, red and white horizontal stripes, with

staff and St. George Cross.

9. Castle Bay Bury, Sea of the Hebrides, will be spherical, red and white horizontal stripes, with staff and St. George Cross.

10. Binch Rock Buoy, Sound of Barra, will be spherical, red and white horizontal stripes, with staff and St. George Cross.

As the date of these alterations taking place is doubtful, Mariners must keep a look-out for them, as now intimated.

RED SEA-EAST SHORE.-JIDDAH APPROACH. (1.) Middle Gateway - South Beacon Destroyed, North Beacon Damaged.

INFORMATION has been received from Commander J. E. Blaxland, H.M.S. "Griffon," that the white beacon, south side of Middle Gateway, Jiddah approach, has been washed away, and that the red beacon on the north side is much decayed.

These beacons may probably not be re-erected

for some time.

(2.) Perim Harbour Entrance—Alteration in Buoyage.

Information has been received from the Perim

Coal Company, dated 11th June, 1887, that the following alterations have been made in the character of the buoys in Perim Harbour Entrance:

1. Pirie Point Buoy (port hand on entering), has been replaced by a buoy lighted by gas.
