the previous twelve calendar months complied with the conditions as to residence which for the time being are required by law and that both of such yearly payments shall be apportionable between any archdeacon resigning or otherwise avoiding the said archdeaconry or his representatives (as the case may be) and the archdeacon who shall next be collated to the same archdeaconry.

" Provided always and we the said Ecclesiastical Commissioners further recommend and propose with the like consent of the said William Archbishop of York (testified as aforesaid) and also with the consent of the Venerable Robert Jarratt Crosthwaite the present Archdeacon of the said Archdeaconry of York or the West Riding (testified by his having signed and sealed this scheme) that the said annual payment of three pounds hereinbefore recommended to be made to the archdeacon of the said archdeaconry shall be and be taken to be in lieu of and in full substitution for the hereinbefore mentioned payment of nine shillings and two pence per annum now payable by us the said Ecclesiastical Commissioners to the archdeacon for the time being of the said archdeaconry in respect of procurations as aforesaid and that such lastly mentioned payment shall accordingly be held to have ceased and determined as from the first day of January one thousand eight hundred and eighty-six.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of either of them or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of York, C. L. Peel.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fiftyfive; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eightytwo; duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-eighth day of April, in the year one thousand eight hundred and eighty-seven, in the words following; that is to say :--

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the eighth and ninth years of Your Majesty, chapter seventy, of the Act of the fourteenth and fifteenth years of Your Majesty chapter ninety-seven of the Act of the nineteenth and twentieth years of Your Majesty chapter fifty-five and of the Act of the Majesty chapter fifty-five and of the Act of the

thirty-fourth and thirty-fifth years of Your Majesty chapter eighty-two have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint John situate at Cwmbach in the parish of Disserth in the county of Radnor and in the diocese of Saint Davids.

"Whereas at certain extremities of the parish of Disserth and of the parish of Llanelwedd in the county and diocese aforesaid which said extremities lie contiguous one to another and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Disserth and of the said parish of Llanelwedd should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint John situate at Cwmbach as aforesaid.

"Now therefore with the consent of the Right Reverend William Basil, Bishop of the said diocese of Saint Davids as such Bishop and also as the patron in right of his See of the rectory of the said parish of Disserth and with the consent of Edward David Thomas of Wellfield near Builth in the county of Brecknock Esquire the patron of the said vicarage of the said parish of Llanelwedd (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Disserth and of the said parish of Llanelwedd which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint John situate at Cwmbach aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint John, Cwmbach-Llechrhyd.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint John, Cwmbach-Llechrhyd, being :---

"All those two contiguous portions of the parish of Disserth and of the parish of Llanelwedd, both in the county of Radnor and in the diocese of Saint Davids, which said portions are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the chapelry of Llanfihangel Brynpabuan in the county of Brecknock and in the said diocese of Saint Davids from the parish of Llanelwedd aforesaid at the centre of Gwernyfed Ford whereby the road leading from Park Wells into the Builth and Newbridge high road crosses the River Wye and extending thence first northward and then north-eastward along the middle of the first-mentioned road for a distance of thirteen chains or thereabouts thereby passing over the line of the Mid-Wales Railway to the point on the eastern side of the said line of railway where
