**A**T the Council Chamber, Whitehall, the 18th day of July, 1887.

By Her Majesty's Most Honourable Privy Council.

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, and with reference especially to Article 96 of The Animals Order of 1886, do hereby license the Local Authority for the county of Essex, to dig up or cause to be dug up, within fourteen days after the date of this Licence, the carcasses of four pigs belonging to Robert Wright, Innkeeper, which recently died of swine-fever, and were buried by him at Stow-Maries, in the county of Essex, subject to the following conditions:

1. The carcasses shall be dug up in the presence of, and under the superintendence of, an officer specially appointed in that behalf by the Local Authority.
2. The carcasses dug up shall be, as far as practicable, covered with quick lime, and shall then be removed, and re-buried in the presence of, and under the superintendence of, the said officer, as soon as possible in some proper place, and shall be covered with a sufficient quantity of quick lime or other disinfectant, and with not less than six feet of earth.
3. The expenses of and incidental to the digging up, removal, and burial of the carcasses shall be defrayed by the Local Authority.
4. This Licence is revocable by the Privy Council.

(PLEURO-PNEUMONIA.)

**A**T the Council Chamber, Whitehall, the 19th day of July, 1887.

By Her Majesty's Most Honourable Privy Council.

**T**HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—in the county of Chester, comprised within the following boundary, that is to say, from the junction of the Warrington and Northwich-road at Stockton Heath to Kinder's Smithy, from thence by Ashworth's-lane and occupation-road by Whitley reed, by Had's Nook to Swinyard-lane, Swinyard-lane to Knutsford high-road, by Knutsford high-road to the "Dog and Dart," Grappenhall, and thence by the Chester and Altrincham high-road to Stockton Heath aforesaid,—which was declared by Order of Council dated the thirteenth day of April, one thousand eight hundred and eighty-seven, to be an Area infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Area shall, as from the commencement of this Order, cease to be an Area infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twentieth day of July, one thousand eight hundred and eighty-seven.
