MEDITERRANEAN.—GRECIAN ARCHIPELAGO.

(1.) *Paros Island—Harbour Light at Port Parekhia.*

THE Hellenic Government has given notice, that on 13th June, 1887, a harbour light would be exhibited on Fikas Point, north side of entrance to Port Parekhia, Paros Island:—

The light is a fixed white light, elevated 44 feet above the sea, and should be visible in clear weather from a distance of four miles.

The illuminating apparatus is dioptric, or by lenses.

Position, lat. 37° 5' 20" N., long. 25° 8' 25" E.

ASIA MINOR.—GULF OF SMYRNA.

(2.) *Fixed Lights at Foujes Harbour Entrance.*

With reference to Notice to Mariners, No. 41 of 22nd February, 1887, on intended lights at Foujes Harbour Entrance:—

The Turkish Government has given further notice, that on 15th July, 1887, the lights will be exhibited.

1. Two fixed white lights, placed vertically, will be exhibited from the south-west extremity of Oglak Island, north side of Foujes Harbour Entrance; the upper light will be elevated 105 above the sea, and should be visible in clear weather from a distance of 12 miles.

Position, lat. 38° 40' 25" N., long. 26° 43' 25" E.

2. A fixed red light will be exhibited on Deirmen Burnu, the point on the south side of the harbour next westward of the town of Foujes; it will be elevated 65 feet above the sea, and should be visible in clear weather from a distance of six miles.

Position, lat. 38° 40' 5" N., long. 26° 45' 25" E.

BALTIC ENTRANCE.—KATTEGAT.

North Rønner Lighthouse—Intended Alteration in Fog Signal.
