BAY OF BENGAL-COAST OF COROMANDEL. Mahábalipur Pagodas—Exhibition of Fixed

Red Light.

WITH reference to Notice to Mariners, No. 147, of 28th May, 1887, and previous Notice, on intended exhibition of a fixed red light on the conspicuous rock (ruined pagoda of Mahábalipur) about six miles northward of Sadras, and delay in the exhibition of the same :-

Telegraphic information has been received through the India Office, that on 10th July, 1887, the light was exhibited

The light is a fixed red light, elevated 116 feet above the sea, and should be visible in clear weather from a distance of about ten miles.

The illuminating apparatus is dioptric, or by lenses, of the fourth order.

The lighthouse, situated about half a mile inland, is a small turret, painted gray, 26 feet above the ground.

Position. lat. 12° 37' N., long. 80° 11' E.
