THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch, dated 14th June, from Her Majesty's Representative at Lima, of which the following is an extract:—

The quarantine interdiction existing against all arrivals from Chilian ports, has, by a Supreme Decree of the Peruvian Government, been abolished, and vessels now arriving at Peruvian ports with clean bills of health will only be subjected to the usual sanitary precautions, and vessels arriving from a Chilian port, where thirty days have elapsed since the last case of cholera has occurred, will be submitted to a quarantine of observation. All vessels entering and leaving Peruvian ports must be provided with bills of health.

Ships of war are exempted from these rules, excepting when they come from suspicious ports.

Vessels arriving at Peruvian ports without bills of health from ports where bills of health are procurable, will be subjected to a quarantine of observation and fined, but vessels entering the port through stress of weather, in distress, or through other unavoidable circumstances, are exempted from this regulation.
