Sanitary Measures.—Algeria.

A Decree of the Governor-General of Algeria, of the 10th instant, subjects on their reaching Algeria, arrivals from Sicily and Pantellaria, as well as those from the coast of Continental Italy, from Cape Circello on the west to Cape Gorgano on the east, to an observation of which the duration is fixed at seven days for steam vessels and five days for sailing vessels.

Nevertheless those of such arrivals which have called in Tunis and have there undergone the quarantine of eight days applied in the Regency are admitted to free pratique on their arrival in

Algeria.
