THE Board of Trade have received through the Secretary of State for the Colonies the following Quarantine Notice, issued by the Governor of Malta, viz. :—

Government Notice.

His Excellency the Governor, having heard the opinion of the Board of Health, has been pleased to give the following directions :—

1. No vessel which has been in Sardinia within twenty-one days, shall be admitted into this port except for the purpose of taking coals and provisions, in strict quarantine. Vessels will, however, as provided by Government Notice, No. 98, of 18th July last, be allowed to take passengers and cargo in quarantine, provided they do not remain in the harbour longer than is necessary for the purpose of taking coals and provisions.

2. Vessels and passengers arriving from Civita Vecchia shall be subjected to seven days' quarantine.

3. Passengers arriving from any port in the Mediterranean, or Constantinople, as well as those embarking at Alexandria, Suez, and Port Said, will not be permitted to land at Malta, unless provided with British Consular certificates stating that they have not resided or been in any place in Southern Italy, from Terracina to Ancona inclusive, round Cape Spartivento, in Sicily, or in Sardinia, during the twenty-one days immediately preceeding the date of their embarkation.
