## Metropolitan Board of Works.

## THE SLAUGHTER HOUSES, &amp;c. (METROPOLIS) ACT, 1874.

37 and 38 Victoria, cap. 67.

WHEREAS at a Meeting of the Metropolitan Board of Works, now duly holden under and in pursuance of a statute made and passed in a session of Parliament holden in the 18th and 19th years of the reign of Her present Majesty, intituled "An Act for the better Local Management of the Metropolis," and of the statute amending the same, at the offices of the said Board, at Spring-gardens, Westminster, within the district of the said Board, the said Board being satisfied, after due enquiry in that behalf, that the business hereinafter mentioned and described is an offensive business, deem it expedient that the same should be declared to be an offensive business under the 3rd section of "The Slaughter Houses, &c. (Metropolis) Act, 1874." Now, therefore, the said Board, being the Local Authority within the meaning of the said last-mentioned Act, do, under and by virtue of the powers vested in them in that behalf by the last-mentioned Act, now declare by this Order the following business to be an offensive business, that is to say:—

The business of an Animal Charcoal Manufacturer, that is to say, any business in which bones are converted into charcoal, or in which any residual produced in such conversion is dealt with.
