

Aldingham and with the consent of the Reverend Henry Hayman Doctor in Divinity the rector or incumbent of the rectory of the said parish of Aldingham and as such the patron of the perpetual curacy of the chapelry of Dendron aforesaid (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we the said Ecclesiastical Commissioners for England, humbly represent that it would in our opinion be expedient that all those contiguous portions of the said chapelry of Rampside and of the parish of Dalton-in-Furness aforesaid and of the said chapelry of Dendron in the parish of Aldingham aforesaid which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Michael situate within the chapelry of Rampside as aforesaid and that the same should be named 'The Consolidated Chapelry of Saint Michael Rampside.'

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Michael, Rampside, being:—

"All those portions of the parish of Dalton-in-Furness in the county of Lancaster and in the diocese of Carlisle, comprising the chapelry of Rampside and also comprising Roa Island with its approaches, that is to say, Piel Pier, and the line of railway on Roa Ridge which connects such island with the mainland, all which said portions of such parish are bounded upon all sides as follows upon the north-west partly by the new parish of Saint John Barrow-in-Furness and partly by the new parish of Saint Luke Barrow-in-Furness both in the county and diocese aforesaid upon the north-east by the chapelry of Dendron in the parish of Aldingham in the same county and diocese upon the south-east partly by the last-named chapelry and parish and partly by the ordinary high water mark upon the sea shore, and upon the south-west by the said high water mark.

"And also all that contiguous portion of the said parish of Aldingham which is comprised within that part of the chapelry of Dendron aforesaid which is bounded upon the south-east by the said ordinary high water mark upon the sea shore, upon the west and upon the north-west by the hereinbefore described portion of the parish of Dalton-in-Furness aforesaid, and upon the remaining side that is to say upon the north-east by an imaginary line commencing at the point where the boundary which divides the last-mentioned parish from the parish of Aldingham aforesaid diverges from the course of the stream called or known as Sarah Beck and extending thence south-eastward along the middle of the said stream for a distance of eight chains or thereabouts to the north-western end of the culvert through which the same stream is discharged into the sea and continuing thence still in precisely the same direction and in a straight line to the said ordinary high water mark upon the sea shore as aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the

same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Carlisle.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; of the Act of the third and fourth years of Her Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the tenth day of November, in the year one thousand eight hundred and eighty-seven, in the words following; that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Your Majesty, chapter forty-nine; of the Act of the third and fourth years of Your Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five, have prepared; and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Andrew situate at Lower Streatham in the new parish (sometime district chapelry) of Emmanuel Streatham, in the county of Surrey and in the diocese of Rochester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Andrew situate at Lower Streatham as aforesaid.

"Now therefore, with the consent of the Right Reverend Anthony Wilson Bishop of the said diocese of Rochester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said new parish of Emmanuel Streatham, which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Andrew situate at Lower Streatham as aforesaid, and that the same should be named 'The District Chapelry of Saint Andrew Lower Streatham.'

"And with the like consent of the said Anthony Wilson Bishop of the said diocese of Rochester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Andrew situate at Lower Streatham as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church
