The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter one hundred and four, and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and forty-two, duly prepared and laid before Her Majesty in Council a scheme, bearing date the tenth day of November in the year one thousand eight hundred and eighty-seven, in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four and of the Act of the twenty-third and twenty-fourth years of Your Majesty chapter one hundred and forty-two have prepared and nowhumblylay before Your Majestyin Council the following scheme for constituting a separate district for spiritual purposes out of the parish of Saint Anne Limehouse and out of the parish of All Saints Poplar both in the county of Middlesex and in the diocese of London.

"Whereas it appears to us that it would promote the interests of religion that the particular portions of the said parishes of Saint Anne Lime-

house and of All Saints Poplar respectively which are mentioned and described in the schedule to this scheme and are delineated on the map or plan annexed to this scheme should be constituted a separate district for ecclesiastical purposes by the name of 'The District of Saint Peter Limehouse:'

"And whereas the constitution of the said proposed district by the name aforesaid and the endowment of the same and the provision of a church for the same as hereinafter-mentioned and the assignment of the patronage of the same district and new parish as hereinafter-mentioned are respectively contemplated and eventually provided for by a certain Order of Your Majesty in Council bearing date the fifth day of May in the year one thousand eight hundred and seventythree and published on the day following in the London Gazette; by which Order the benefice of Saint Helen Bishopsgate in the city and diocese of London and the benefice of Saint Martin Outwich in the same city and diocese were united into one benefice:

"And whereas the Master and Wardens of the Merchant Taylors of the Fraternity of Saint John the Baptist in the city of London (hereinafter called 'The Merchant Taylors' Company') were at the date of the said Order the patrons of the said benefice of Saint Martin Outwich and they consented that the endowment, as in the same Order and in this scheme is mentioned, of the said proposed district of Saint Peter Limehouse, and that the provision of a church for the same district, which is hereinafter-mentioned, should be provided and made out of funds accruing from the said benefice and church of Saint Martin Outwich and from the site thereof upon the understanding and condition that the patronage of the said proposed district of Saint Peter Limehouse should be assigned to them and their successors as is

hereinafter recommended and proposed:

"Now therefore with the consent of the Right Honourable and Right Reverend Frederick Bishop of London (in testimony whereof he has set his hand and his episcopal seal to this scheme) we the said Ecclesiastical Commissioners for England humbly recommend and propose that all those portions of the said parish of Saint Anne Limehouse and of the parish of All Saints Poplar which are described in the schedule hereunder written and are delineated on the map or plan hereunto annexed shall upon and from the day on which any Order of Your Majesty in Council ratifying this scheme shall be published in the London Gazette become and be constituted a separate district for spiritual purposes by the name of 'The District of Saint Peter Limehouse' and we the said Commissioners do in pursuance of the powers and provisions contained in the said secondly-recited Act hereby specify as the parish church of the district of Saint Peter Limehouse so herein recommended and proposed to be constituted a building which has been erected out of such funds as are hereinbefore mentioned on land situate in Garford-street within the limits of the said proposed district of Saint Peter Limehouse the same site having been by an indenture bearing date the thirteenth day of December in the year one thousand eight hundred and eighty-two and since deposited in the Registry of the diocese of London duly conveyed to us the said Commissioners as and for the site of a church for the said intended district of Saint Peter Limehouse. And we do with the consent aforesaid and in fulfilment of the aforesaid provisions of the said Order of Your Majesty in Council of the fifth day of May one thousand eight hundred and seventy-three hereby recommend and propose
