#### GENERAL ORDER of the Local Government Board; Regulations as to Vaccination; Amending Order as to Re-vaccination:—

To the Guardians of the Poor of the several Unions and Separate Parishes in England and Wales;—

And to all others whom it may concern.

WHEREAS the Lords of Her Majesty's Most Honourable Privy Council on the 18th day of February, 1868, made and issued an Order prescribing certain Regulations for securing the efficient performance of Public Vaccination, and
