#### Golden Valley Railway Bill.

(Alteration of Plan of proposed New Railway.)  
NOTICE is hereby given, that the promoters of the above-named Bill are applying to Parliament for leave to introduce into the said Bill, as now pending in the House of Lords, all necessary provisions to enable the Company to be incorporated by the intended Act, to substitute for part of the railway described on the deposited plans as Railway No. 5 (No. 4 in the Bill) a piece of railway as hereinafter described, viz.:—

A railway commencing in the parish of St. Maugham, or St. Maughans, in the county of Monmouth, in a field on the western side of the River Monnow, near and to the southward of Clapper's Wood, at a point marked as three miles and five furlongs from the intended commencement of the said Railway No. 5, as shown on the plans deposited in relation to the said Bill in November last, with the respective Clerks of the Peace of the counties of Here-

ford and Monmouth, passing thence into and through the parishes of Llanrothall in the county of Hereford, and Monmouth in the county of Monmouth, and terminating in the said parish of Monmouth at the point shown on the said deposited plans, as the intended termination of the said Railway No. 5, in the field on the western bank of the River Monnow, numbered 520 on the 25-inch ordnance map in that parish.

To authorise the purchase and taking of land by compulsion or agreement, and the crossing of roads and highways for the purposes of the said altered railway, and the levying of tolls, rates, and charges for or in respect of the use thereof.
