N.E. for Jezirat-al-hara, keeping this islet on that bearing until Jezirat Amkads, bears E. $\frac{1}{2}$ S.. when course may be altered to E. by N. $\frac{1}{2}$ N.; proceeding midway between Jezirat-al-bara and Jezirat Amkads, until Amkads bears S.W. $\frac{3}{4}$ S., which islet should then be kept on that bearing astern to lead to the anchorage off Om-Rasás.

Brighton Marine Palace and Pier Bill. (Additional Provision ; Change of Site of New Pier, &c.)

NOTICE is hereby given, that a Bill under the above short title is now pending in the House of Lords, and plans and sections of the pier and works described in the said Bill were deposited for public inspection with the Clerk of the Peace for the county of Sussex, and with the parish clerk of Brighton, on or before the 30th day of November last.

It is intended to apply to the House of Lords by petition for additional provision on the meeting of that House after the Easter vacation, for leave to relinquish the construction of the pier and works described in the said Bill, on the site of the old Chain Pier, as shown on the said deposited plans, and to substitute, make, and maintain a pier and works on the new or altered site next hereinafter described, viz. :--

- A promenade pier, jetty, and landing and shipping place, in the parish and borough of Brighton, and on the adjoining beach, foreshore, and bed of the sea, in the county of Sussex, commencing at a point on the seawall on the southern side of Grand Junctionroad, 25 yards, or thereabouts, measured in an easterly direction along the said sea-wall from the eastern side of the steps leading to the stone groyne, nearly opposite the eastern end of the Albion Hotel, and thence extending seawards in a southerly direction, and terminating at a point in the bed of the sea, distant 666 yards, or thereabouts, from the said point of commencement, with a pierhead or promenade at or near the scaward end of the pier.
- All proper landing and shipping stages, stairs, shelters, approaches, saloons, pavilions, assembly, and concert rooms, reading and refreshment rooms, baths, and other buildings, toll houses, gates, cranes, buoys, mooring posts, and other works and conveniencesupon or connected with the pier, pier-head, and landing and shipping place.

Provision will be made in the said Bill for the purchase of land and other property, by compulsion or agreement, for the purposes of the intended new pier and works, and for levying of tolls, rates, fares, and charges for the use of the pier and works, buildings, and conveniences, and for the use of the steamboats provided by the Company to be incorporated by the Bill, and for varying or extinguishing existing tolls, fares, rates, and charges, and all such rights and privileges as may interfere with the construction or use of the pier and works, and generally to amend or apply the several provisions of the said Bill, the Parliamentary deposit, and the share and loan capital to be raised under the powers of the Bill to such new or substituted pier in like manner and to the same extent as if the same had been delineated on
