(Power to Borrow Money for Defraying Extra Cost of Increasing Width of Diversion of Manor-road, West Ham, authorized by Great Eastern Railway Act, 1882, and Great Eastern Railway (General Powers) Act, 1883; Extension of Provisions of Bill as to Transfer of Jurisdiction of Commissioners of Sewers; Amendment of Acts, &c., &c.)

OTICE is hereby given, that application will be made in the House of Commons for leave to amend the Bill now pending in that Honourable House under the above name or short title, and to make additional provision therein for effecting the purposes, or some of the purposes following, that is to say :--

To enable the Mayor, Aldermen, and Burgesses of the borough of West Ham, in the county of Essex (hereinafter referred toas "the Corporation"), to borrow money on the security of any of their funds, rates, and revenues, and property for the purpose of defraying the extra cost of increasing the width of the diversion of the portion of the Manor-road, in the parish of West Ham, which by the Great-Eastern Railway Act, 1882, as amended by the Great Eastern Railway (General Powers) Act, 1883, the Great Eastern Railway Company were authorized to make to 40 feet instead of 30 feet, and so far as may be necessary to amend the said Acts of 1882 and 1883, and any other Act or Acts relating to the Great Eastern Railway Company or their undertaking.
