southerly fence of three fields called Carys Fields, 1 through the gate and by the easterly fence of Crockers field all in the occupation of Mr. Henry Bradley of Sock Dennis, thence by the brook on the easterly side of Great Marsh Field, crossing the brook thence along by the fence on the easterly side of Little Pennings and Great Ship Hays field to the 1 rook, thence along by the fence on the easterly side of Little Worman Field to Cow Shed, thence along the fence on the easterly side of Great Worman Field to the fence adjoining the main-road from Yeovil to Ilchester and terminating at the Cow Inn.

## (Swine-Fever.)

1. The following Areas (namely),—(1) at Bearsted, in the county of Kent, comprised within the following boundary, that is to say, commencing at a point at the south-east corner of Vintners Park known as Huntsmanslane, along the high-road to the corner by Gidds Pond, thence to the White Horse Bearsted, thence to the Kentish Yeoman Bearsted, and thence by the Ashford main-road to the corner of the caid Huntsmans-lane; the whole of the high-roads adjoining such area being included in the Arca, and (2) at Loose and Boughton Monchelsea in the county of Kent, comprised within the following boundary, that is to say, commencing at a point known as the corner of Tyler's-lane by the High-road leading to Boughton Green, from thence to Mr. Mark Atkins' Malt House, from thence by the stream as far as Loose Bridge, and from thence by the road leading into Tyler's-lane to the point known as Tyler's corner aforesaid, - which were declared by Orders of Council dated respectively the fourteenth day of June, and the twenty-second day of August, one thousand eight hundred and eighty eight, to be Areas infected with swinefever, are hereby declared to be free from swinefever, and those Areas shall, as from the commencement of this Order, cease to be Areas infected with swine-fever.
