WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a sum of six hundred pounds sterling, which has been paid to us in favour of the consolidated chapelry and benefice (hereinafter called the benefice) of Saint Andrew, Livesey, in the county of Lancaster, and in the diocese of Manchester, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said benefice of Saint Andrew, Livesey, to meet such benefaction, one other capital sum of six hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said benefice, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of two pounds and ten shillings per centum per annum, and such interest to be paid to the Incumbent for the
