## Isle of Man.

26. These Regulations shall apply to the Isle of Man, with the following modifications (that is to

I. The expression "lunacy trustee" means a person entrusted by Her Majesty's High Court of Justice of the Isle of Man with the application of the property of a person of unsound mind under the law for the time being in force in the said Isle.

II. The receipt of the executor or administrator named in the probate of the will or administration of the estate and effects of a deceased depositor granted by the said High Court of Justice of the Isle of Man, shall be a good discharge to the trustees for any sum payable in respect of the deposits of any deceased depositor domiciled in the said Isle.

WHEREAS the Poor Law Commissioners and the Poor Law Board by General Orders dated respectively the eighth day of December, one thousand eight hundred and forty-seven, and the twenty-seventh day of June, one thousand eight hundred and seventy-one, made certain rules and regulations relating to the administration of relief to the Poor within the Union, the Parishes, and the Township therein mentioned, including the Parish of Saint George in the East;

And whereas by Article 181 of the first abovecited Order provision was made for the payment of special fees to Medical Officers in certain cases, and by Article 31 of the last above-cited Order it was directed that such provision, amongst others, should apply to the Medical Officer of the Infirmary of the said Parish;

And whereas it is expedient to suspend, as hereinafter mentioned, the operation of the said Article 181 as regards the Medical Officer or Officers for the time being of the Workhouse and

Now, therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby suspend, with respect to the Medical Officer or Officers for the time being of the Workhouse and of the Infirmary of the said Parish of Saint George in the East, the operation of Article 181 of the said General Order dated the eighth day of December, one bousand eight hundred and forty-seven, until

We, by an Order under Our Seal of Office, shall otherwise direct.
