

the Ordnance Map for the said parish of Littlebury are numbered 90, 122, 123, 124, 126 to 139 inclusive 209, 210, 212 to 217 inclusive and 219 to 227 inclusive.

"The boundaries of such district will therefore be as follows:—

"The boundary commences at the point where the boundary between the parishes of Strehall and Littlebury meets north-eastern side of the enclosure numbered 224 on the Ordnance Map for the parish of Littlebury (known as How Wood) and proceeds eastwards along the north-eastern boundary and thence along its eastern and south-eastern boundary to the south-eastern corner of the field numbered 225 thence along its southern boundary to the point where it meets the road leading from Strehall to Littlebury thence southward and along the centre of the said road to the south-eastern corner of the field numbered 210 thence along the southern boundary of that field and across the roadway called Birch-lane to the south-eastern corner of the field numbered 209 thence along the southern boundaries of that field and of the fields numbered 139 and 122 and across the lane or roadway leading from Strehall to Littlebury Green to the south-eastern corner of the field numbered 123 thence along the southern boundary of that field and the enclosure numbered 124 and the field numbered 90 to the point where the boundary of the last-mentioned field meets the boundary between the parishes of Elmdon and Littlebury thence northward along the said boundary till it meets the boundaries between the parishes of Strehall and Littlebury thence eastward along the last-mentioned boundary to the point where the boundary now being described commenced.

"It is further proposed to separate a district from the parish of Saffron Walden and to annex the same for ecclesiastical purposes to the said parish of Littlebury. The said district is delineated and described in the said plan hereto annexed and is there coloured green and consists of the lands which on the said Ordnance Map for the said parish of Saffron Walden are numbered 125 to 134 inclusive 309 to 313 inclusive 317 to 325 inclusive 327 to 335 inclusive part of 336, 337 to 341 inclusive 343, 344 and part of 363.

"The boundaries of such district will accordingly be as follows:—

"The boundary commences at the point where the boundary between the parishes of Little Chesterford and Saffron Walden cuts the eastern side of the field numbered 126 on the Ordnance map for the parish of Saffron Walden aforesaid at its north-eastern extremity and proceeds southwards along the eastern sides of that field and of the field numbered 132 and crossing the lane or roadway leading to North End at its junction with the high road leading from Saffron Walden to Great Chesterford to the northernmost corner of the field numbered 313 thence southward along the eastern side of that field and of the field numbered 317 and across the roadway numbered 328 leading from Littlebury to Saffron Walden to the north-easternmost corner of the enclosure numbered 363 (known as Spring Wood) thence it proceeds in a south-westerly direction along a pathway through the said wood till it meets the north-eastern boundary of the field numbered 336 thence south-westerly across the said field to the north-easternmost corner of the field numbered 337 thence along the eastern sides of that field and the field numbered 339 and along the eastern boundary of the enclosure numbered 341 (known as Duck-street) and crossing the stream which forms the southern and south-western boundary of that

enclosure it proceeds westerly along the pathway abutting on the said stream thence in a south-westerly and westerly direction along the centre of the lane or roadway leading to the high road to Littlebury to the point where the boundary between the parishes of Littlebury and Saffron Walden crosses that lane or roadway thence it follows the said boundary northward to the point where it meets the boundary between the parishes of Little Chesterford and Saffron Walden and proceeds along the latter boundary to the point where it cuts the eastern side of the field numbered 126 at its north-eastern extremity being the point where the boundary now being described started.

"That the incumbent of the benefice of Strehall shall have the sole and exclusive cure of souls within the district proposed to be annexed to the parish of Strehall.

"That the parishioners of such district shall be exonerated from all liability to repair the parish church of Littlebury but shall be liable to the repairs of the parish church of Strehall.

"That the incumbent of the benefice of Littlebury shall have the sole and exclusive cure of souls within the district proposed to be annexed to the parish of Littlebury.

"That the parishioners of such last-mentioned district shall be exonerated from all liability to repair the parish church of Saffron Walden but shall be liable to the repairs of the parish church of Littlebury.

"That the fees for marriages churchings and burials and other ecclesiastical dues offerings and emoluments arising from the said districts shall henceforth belong to the incumbents of the benefices to which they shall respectively be annexed.

"We the Right Honourable Charles Cornwallis Baron Braybrooke being the patron or person entitled to present to the benefices of Littlebury and Saffron Walden in the county of Essex and diocese of St. Albans, in case the same were now respectively vacant Hector Monro of Edmonsham in the county of Dorset Esquire Charles Mansfield Clarke of the United Service Club, Pall Mall in the county of Middlesex a Major-General in Her Majesty's Army C. B. Turner Collin of Saffron Walden Esquire and Richard Lluellyn of the Army and Navy Club Pall Mall in the county of Middlesex a Colonel in Her Majesty's Army being the patrons or persons entitled to present to the benefice of Strehall in case the same were now vacant Ernest Edward Edgerley Clerk Incumbent of the said benefice of Littlebury Joseph Collin, Clerk Incumbent of the said benefice of Strehall and Thomas Stevens Clerk Incumbent of the said benefice of Saffron Walden do hereby respectively signify to your Grace our several consents to the scheme above proposed for separating a district from the parish of Littlebury and annexing the same to the parish of Strehall and for separating a district from the parish of Saffron Walden and annexing the same to the parish of Littlebury.
