Barra Strait (Big Narrows)—Lights on Railway Bridge in Course of Construction.

THE Government of the Dominion of Canada has given notice, dated 26th July, 1889, that lights would be shown from the piers of a railway bridge now in course of construction, from Uniacke Point to Kelly Point, Barra Strait, Bras d'Or Lake, Cape Breton Island:-

The lights are red lights, and vessels must pass on the southern side of any such light shown.

When the bridge is completed, the swinging portion will be on the southern side of the Strait; and from the middle of the superstructure of the central pier of the swing, a fixed light will be exhibited, showing red up and down the channel
