#### OVERTIME.—ADDITIONAL TWO HOURS (PERISHABLE ARTICLES).

*Order of Secretary of State extending Special Exception.*

WHEREAS the Factory and Workshop Act, 1878, contains a special exception to the effect that the regulations of the Act with respect to the employment of young persons and women shall not prevent the employment in the factories and workshops or parts thereof to which the exception applies of women during a period of employment beginning at 6 A.M. and ending at 8 P.M., or beginning at 7 A.M. and ending at 9 P.M., if they
